Victim: Kristin Januseski

Accused: Jason Carty

On Monday, October 24, 2016 at 13:50 hours, Kristin Januseski and Jessica Love came to Police Headquarters to report the theft of a political campaign sign that occurred on Saturday 10/22/16 at approximately 18:00 hours.

Ms. Januseski stated that her friend Ms. Love witnessed a man remove a Januseski campaign sign from the intersection of Bobby's Run Blvd and Westminster Drive, and replaced it with a Benson Campaign sign. Ms. Love followed the man and confronted him. Ms. Love told me that she did not identify the man at the scene, and was unable to obtain a license plate number. Ms. Januseski suspected that it may be Jason Carty who took the sign, and after showing Ms. Love a photo of Mr. Carty, Ms. Love confirmed it was in fact Mr. Carty who took the sign.

I had Ms. Januseski complete a Victim Property Loss Report, with a value of \$4.00 for the campaign sign. Additionally, I had Ms. Love complete a Voluntary Statement, detailing her interactions with who she believes to be Jason Carty. Ms. Januseski stated she does not want to file complaints at this time, but would like the case to be documented as a matter of record.

Victim: Kristin Januseski

On Monday October 24, 2016 at 1800 hours I was advised to contact Jason Carty in reference to this case. I spoke with Carty and he reported that on Saturday October 22, 2016 at approximately 1815 hours he was confronted by an unknown white female who accused him of stealing and damaging campaign signs for Kristin Januseski. Carty stated that at the time he was fixing a damaged campaign sign for Terrance Benson. He stated he told the woman this and invited her to look in his truck to verify that he was not stealing signs and he said she refused. He stated he could not identify the woman as his vision was impaired by the headlights of her vehicle, which he described as a silver SUV or crossover.

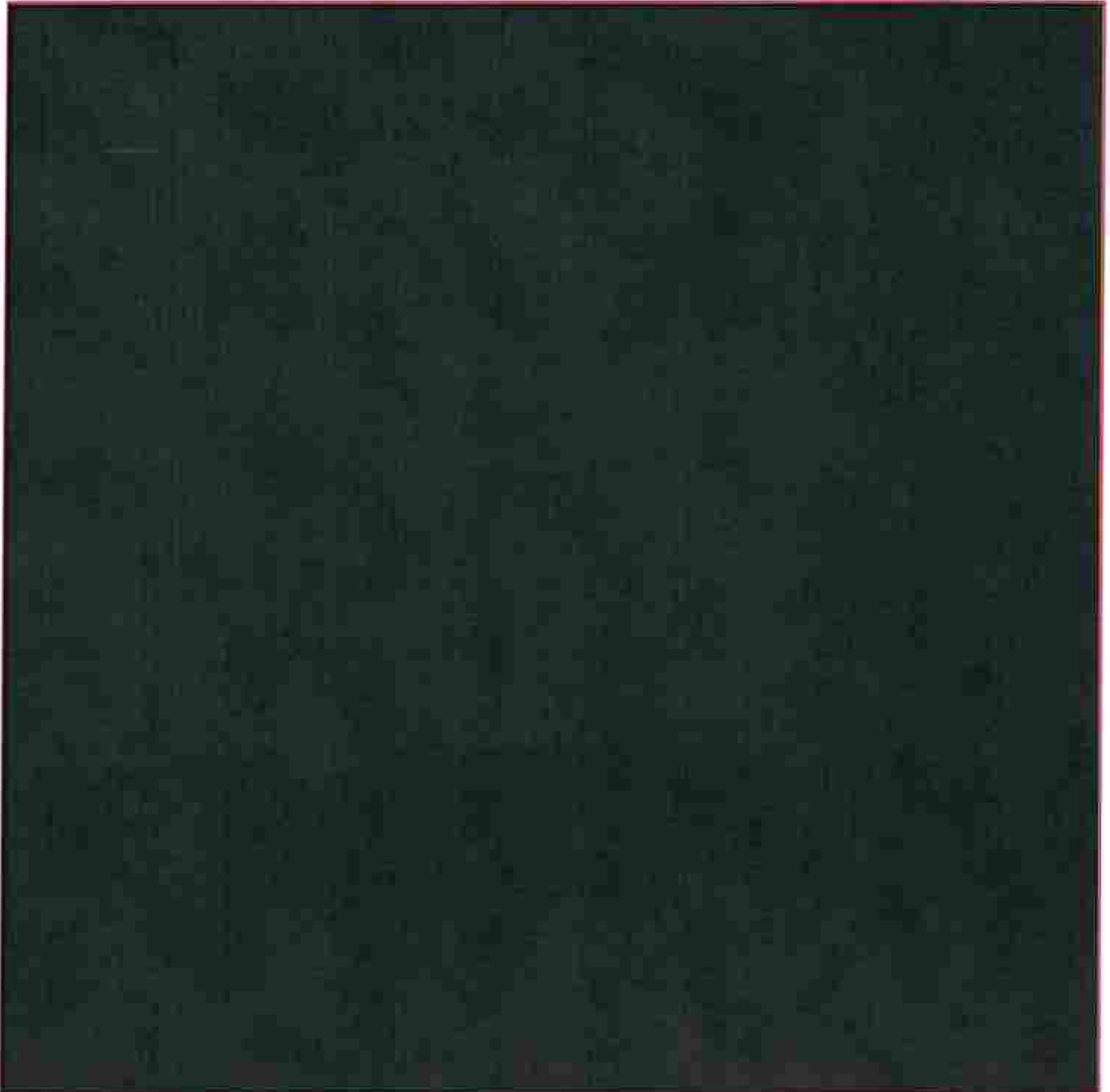

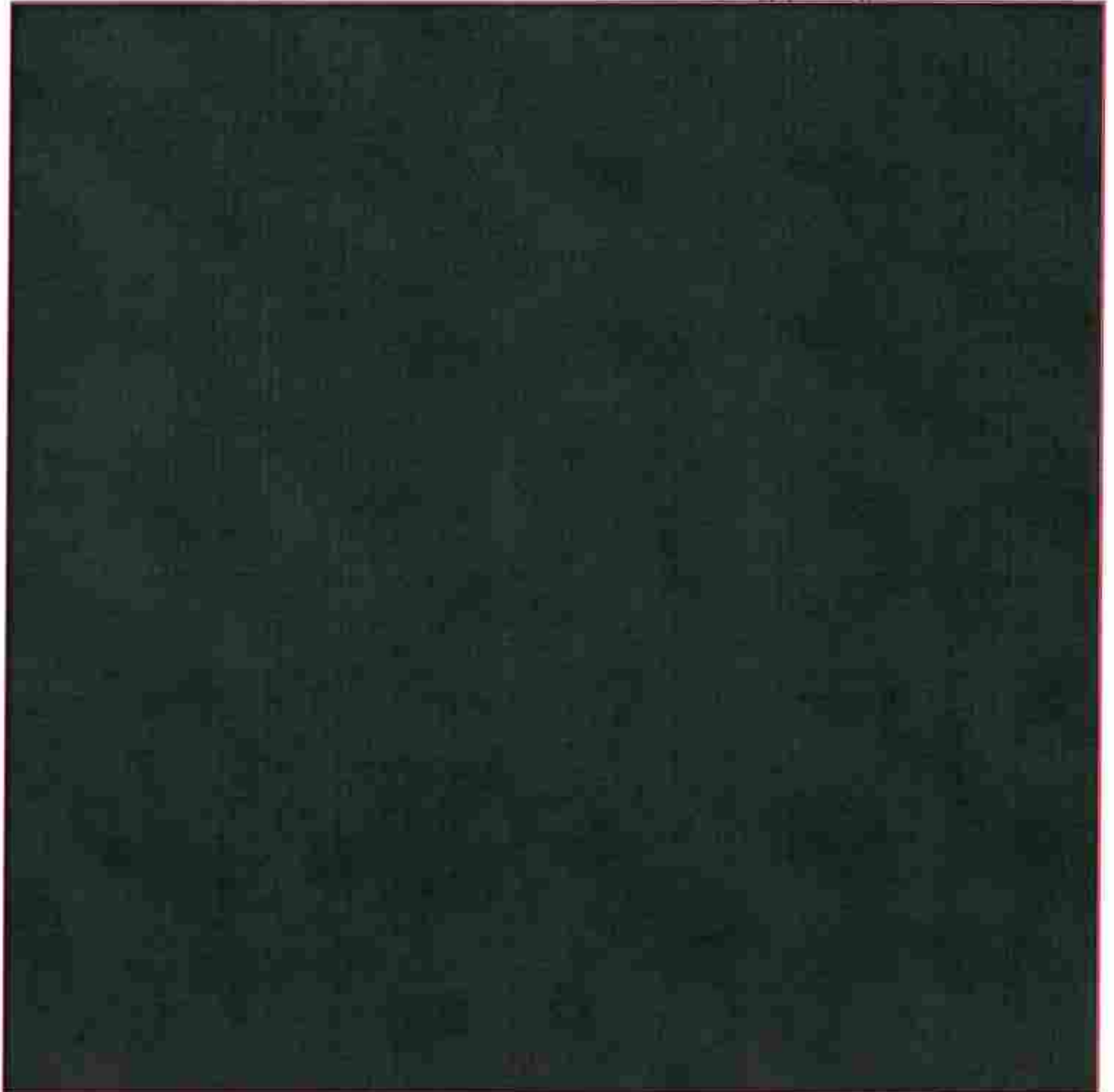

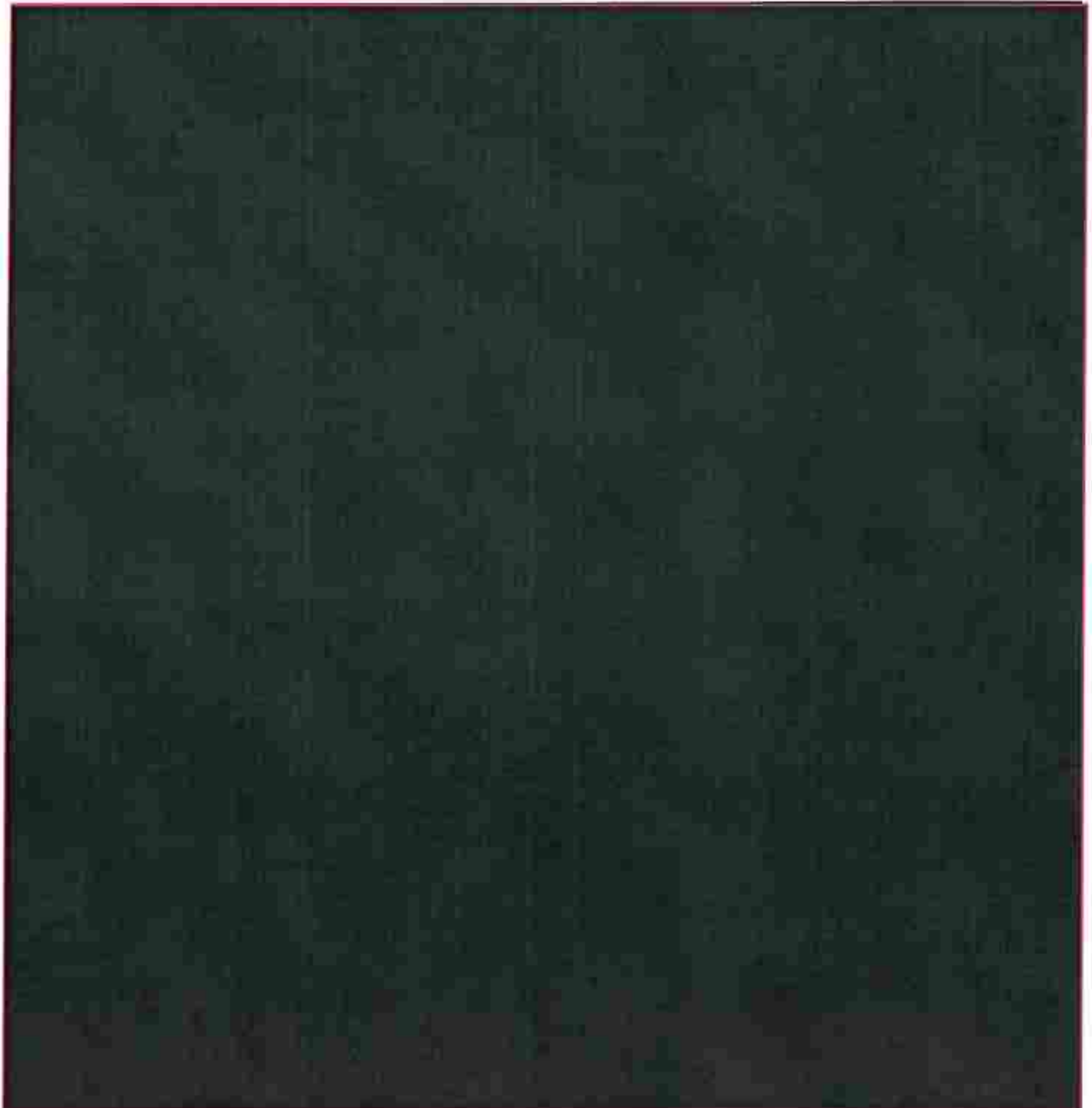

Tommins stated that his political opponent's husband, who he identified as Mr. Jason Carty, was harassing him by driving his vehicle and honking the horn in front of his residence which is located at 114 Harrogate Drive, Lumberton, NJ, 08048.

Tommins said that the harassment is occurring due to Mr. Carty's wife, (Gina LaPlaca) winning a recent election against him. Tommins also received a robo number [REDACTED] text message with a screenshot displaying the message, "When you ask ppl to join you in attacking a domestic violence survivor and no one shows up". Tommins stated that he would be providing video footage of the incident which was captured on his ring camera as well as the screenshot he received.

While at Police Headquarters, Tommins, completed and signed a Probable Cause Statement Form. Shortly after, citizen's complaint number 0318 2023 338 was generated for 2C:33-4C (Harassment) through NJCourts. Tommins was then advised that the complaint would be sent to the court for the finding of probable cause in which he acknowledged. Tommins signed the complaint and left Police Headquarters without further incident.

The ring camera footage provided by Tommins, and screenshot that was allegedly sent by Mr. Carty was entered into evidence as "JR1", as well as uploaded into "Evidence.com".

At this time, there is nothing further to report as the complaint was forwarded to the court for the finding of probable cause.
