Narrative

At the location, I met with Jennifer Coombs and the homeowner, Marie Dewoolf. Dewoolf reported that her neighbor (Robert Champouillon) at 19 Evergreen Avenue called the police on Coombs this past Friday because he did not want Coombs approaching or talking to him. According to Coombs and Dewoolf, Robert parked his personal vehicle directly in front of her house the following day after the incident and they feel it was in retaliation. It should be noted that Robert resides across the street from Dewoolf. I advised both, Coombs and Dewoolf that people can park anywhere in the public street as long he/she is not in violation of any parking laws. Dewoolf indicated that she understands, however she felt it was strange that he would park in front of her residence the following day after the complaint. Dewoolf and Coombs advised that they do not want any problems and just want this incident documented.
