Narrative

Robert Champouillon came into Neptune City Police Headquarters in order to apply for a Temporary Restraining Order against Jennifer Coombs. Champouillon was in NCPD Headquarters yesterday filing a Harassment complaint against Coombs in which Coombs was subsequently arrested and committed to the Monmouth County Correctional Institution, ref 20NC07716.

I confirmed that Champouillon and Coombs were never in a dating relationship or lived together, which did not meet the requirements of a TRO. I contacted Monmouth County Prosecutors Office Assistant Prosecutor Matthew Bogner who confirmed Champouillon would not be able to apply for the TRO. AP Bogner did advise should Coombs be released from MCCI, the Judge may impose a No Contact Order. I spoke with AP Stacey Handler, who was assigned to the detention hearing, and she advised she was aware of this case and would speak with Champouillon. I requested she notify me of the outcome of the hearing.
