Doug,

I am trying to build this in our ordering system. Is there a price difference from an "All Band" to just a single band P25? This is being used for a single talkgroup on the NJSP NJICS system (700/800MHz) P25.

As I am looking at the pricing, I see there is a credit to remove VHF and UHF bands, but there is only a credit for removal of VHF band. With that the numbers do not seem to add up. The Motorola price is \$800 per removal, but it looks like only \$600 was removed (See snip). I am assuming the removal is at NJ State Contract, so that means that only 25% of the removal is "removed"? If that is not the case, then 2 bands removed at \$800 per band would be \$1600, and only \$600 was removed.

Please review and advise. If this needs to be changed, please try to get this to me ASAP so I can submit. It appears that Motorola Solutions is already set up in our ordering system. It generally takes a week for them to build the item for me.

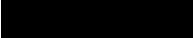

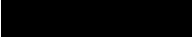

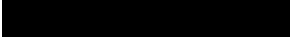

As we begin to shape this new partnership, I want to make sure we proceed correctly in the eyes of Piscataway leadership, and approach requests from additional stakeholders in the proper manner. I have received emails from both River Rd and North Stelton volunteer leadership requesting meetings to discuss EMS operations at this point, and before I respond, I wanted to check in with you. My thought was to schedule those meetings for after our initial meeting on the 4th, and discuss the ins and outs of those relationships at that meeting with you to get the lay of the land and what the partnerships should look like. We are more than willing to defer to PD as the central coordinator of those interactions, and I do not want to commit to a meeting with the organizations if that is not the will of township leadership. Please let me know if it would be ok to schedule those meetings for mid August after our meeting, or if I need to confirm this with someone else, please point me in the right direction.
