THIRD DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that FELICIA S. ST. JOHN, NICHOLAS J. ST. JOHN, DERRICK T. BECKETT and JIMMY W. REED, on or about October 21, 2019, in or about the Township of Freehold, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Conspiracy, by unlawfully agreeing with each other that they, or any one or more of them, would commit the crime of Distribution of a Controlled Dangerous Substance, with the purpose of promoting or facilitating the commission of said crime and that in pursuance of such conspiracy and to effect the object thereof, contrary to the provisions of N.J.S.A. 2C:5-2, and N.J.S.A. 2C:35-5b(5), and against the peace of this State, the Government, and dignity of the same.

SECOND COUNT

DISTRIBUTION OF A CONTROLLED DANGEROUS SUBSTANCE

THIRD DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that FELICIA S. ST. JOHN, on or about October 21, 2019, in or about the Township of Freehold, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Distribution of a Controlled Dangerous Substance, by knowingly or purposely distributing a controlled dangerous substance, to wit: suboxone, to Nicholas J. St. John and/or Derrick T. Beckett and/or Jimmy W. Reed, contrary to the provisions of N.J.S.A. 2C:35-5b(5), and against the peace of this State, the Government, and dignity of the same.

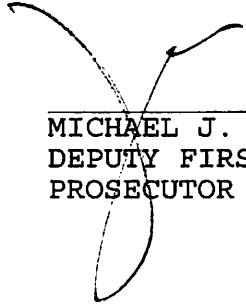

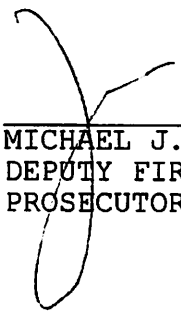

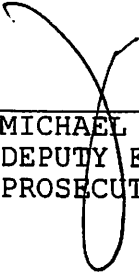
