Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

Police Officers were dispatched to the Crystal Inn Professional building for a report of a shooting. Upon arrival the officers located one victim, Kamron Brewington, who suffered serious life threatening injuries due to the fact that he was shot twice. The victim was transported to the hospital and brought into emergency surgery to save his life. Also present during the time of the shooting was Tahmel Brazile. Brazile also stated that he was shot at by the defendants but was uninjured. The defendant was observed at the Crystal Inn Motel on surveillance cameras prior to the incident. The video footage shows the defendant walking from the lobby of the Crystal Inn Motel. The surveillance video captures a clear image of the suspects face which was utilized to positively identify him. The accused left the motel lobby and walked to the area of 68 Country Club Road and back to the Crystal Inn Professional building. Cameras also show the defendant going inside the professional building and running away from the building after the shooting occurred. The defendant ran back to the area of 68 Country Club Road after the incident. Reference photographs of the suspect were acquired by utilizing government databases and social media platforms. Those photographs were compared the the subject in the surveillance video and utilized to confirm the identify of this defendant. A lifelong acquaintance of the accused also accused also viewed the photographs and confirmed the defendants ID. The defendant also confessed to being at the scene with the other two co-defendants. He admitted to wearing a mask, knowing Brazile was on location and going to the scene to retaliate for an assault against him by Brazile in the past. The defendant knew someone was shot during the incident but did nothing to assist the victim.

2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

Observations are limited to the surveillance video that was recovered and placed into evidence. The video was utilized to identify the defendant. The video also indicated that the defendant went back to his residence after the incident. Several spent shell casings were recovered at the scene and the injuries to the victim were consistent with a gunshot wound. Witnesses also provided statements indicating that they heard gunshots, observed blood and spent shell casings on the floor. Defendant also was interviewed and confessed to being involved in the crime.

3. If victim was injured, provide the extent of the injury:

Kameron Brewington was shot once on the left side of his torso and once on his left wrist. I observed the wound to his torso had large amounts of blood gushing out of it. He was unconscious on scene, lost a lot of blood and was obvious that he was in need of medical attention. Brewington was brought into the operating room and operated on for approximately three hours. During that time it was determined that he had serious internal bleeding due to the gunshot wound.
