Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The Ocean County Prosecutor's Office (OCPO) High-Tech Crimes Squad (HTCS) was assigned an investigation after our office received a referral from the National Center for Missing and Exploited Children (NCMEC) Regional Task Force. The incident, references National Center for Missing and Exploited Children (NCMEC) CyberTip Number [REDACTED] and OCPO Investigation Number 250500324. The CyberTip was reported by Kik to NCMEC, in regards to content shared on Kik. The investigation revealed an image was posted by IP address [REDACTED], which came back to 2225 Edgar Road, Point Pleasant Borough, New Jersey.

On August 22, 2025, the Ocean County Prosecutor's Office High Tech Crimes Unit conducted a residential search warrant at 2225 Edgar Road, Point Pleasant Borough, NJ and seized several electronic devices.

This affiant and Det. Travis Popiel interviewed John Olson, a resident of 2225 Edgar Road, back at Point Pleasant Borough Police Department. John Olson was advised of his Miranda Rights and he signed the Waiver Form. John Olson waived his rights and agreed to speak to us.

During the interview, John Olson confirmed his cell number, [REDACTED] which was a verified phone number provided from subpoena return for upload IP address [REDACTED] from cybertip [REDACTED]. He also confirmed his email address as [REDACTED] which matched the email from cybertip [REDACTED].

A communication data warrant was approved by Judge Guy Ryan on August 20, 2025 for the Kik account [REDACTED]. Upon review of the return the following information was reviewed and found the account to have possession of child sexual abuse material as well as distribution of child sexual abuse material.

More specifically by:

On March 04, 2025 account [REDACTED] share one image of child sexual abuse material with Kik account username [REDACTED].

Supervising Assistant Prosecutor Shanon Chant Berry approved charges of third degree possession of child sexual abuse material N.J.S.A. 2C:24-4B(5)BIII and second degree distribution of child sexual abuse material 2C:24-4B(5)a(1).

Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The Ocean County Prosecutor's Office (OCPO) High-Tech Crimes Squad (HTCS) was assigned an investigation after our office received a referral from the National Center for Missing and Exploited Children (NCMEC) Regional Task Force. The incident, references National Center for Missing and Exploited Children (NCMEC) CyberTip Number [REDACTED] and OCPO Investigation Number 250500324. The CyberTip was reported by Kik to NCMEC, in regards to content shared on Kik. The investigation revealed an image was posted by IP address [REDACTED], which came back to 2225 Edgar Road, Point Pleasant Borough, New Jersey.

On August 22, 2025, the Ocean County Prosecutor's Office High Tech Crimes Unit conducted a residential search warrant at 2225 Edgar Road, Point Pleasant Borough, NJ and seized several electronic devices. This affiant and Det. Travis Popiel interviewed John Olson, a resident of 2225 Edgar Road, back at Point Pleasant Borough Police Department. John Olson was advised of his Miranda Rights and he signed the Waiver Form. John Olson waived his rights and agreed to speak to us. During the interview, John Olson confirmed his cell number, [REDACTED] which was a verified phone number provided from subpoena return for upload IP address [REDACTED] from cybertip [REDACTED]. He also confirmed his email address as [REDACTED] which matched the email from cybertip [REDACTED].

A communication data warrant was approved by Judge Guy Ryan on August 20, 2025 for the Kik account [REDACTED]. Upon review of the return the following information was reviewed and found the account to have possession of child sexual abuse material as well as distribution of child sexual abuse material. More specifically by:

On March 04, 2025 account [REDACTED] share one image of child sexual abuse material with Kik account username [REDACTED]. The image is a nude prepubescent girl. During the chat on Kik the Defendant acted as if he was a 10 year old girl and sent this image of herself to this other Kik user.

During the residential search warrant at 2225 Edgar Road detectives observed cameras in the bedrooms belonging to children at Defendant's residence. The cameras appeared to be ring cameras. Several electronic cellular devices were seized from the residence during the search warrant and forensically examined.

2. I am aware of the facts above because: (Included, but not limited to: your observations, statements of eyewitnesses, defendant's admission, etc.)

Forensic examination of John Olson's cell phone, Samsung Galaxy S22 revealed about 4 still images of a prepubescent child with her intimate parts exposed that appear to be taken from ring camera footage inside the child's bedroom at 2225 Edgar drive. The images appear to be zoomed in on the child's intimate parts. Forensic examination also showed that Defendant was actively logged into a ring.com account from his cellular device, confirming a ring.com account. Subpoena results from Ring.com indicate an active account for the Defendant's email address that includes ring.com devices named by bedrooms belonging to children in the home.
