*For the record and for the people of lacey township,
I continue to do things like accepting a surprise deposition from a shady lawyer pretending she cares about my pain in an attempt to sabotage my potential lawsuit and prevent my closure. Or sharing with your town decision makers my legal-civil intentions rather than just hiring a lawyer, because I am not out to hurt anyone or take money away from children who need it in an already inadequate system.

Even though I knew it was a longshot, I wanted to give your towns decision makers the opportunity to do the right thing rather than the self-serving thing. I am sorry they are only interested in protecting their jobs and revising the schools history to protect its image at your expense.*

To the administrators of Lacey Township, its school board, and its township board:

As I was held as a medical patient under request of the township of lacey and its school system, I am entitled to ALL records related to the school boards out of state request regarding Jonathan Lipman as these are now MEDICAL RECORDS.

I am requesting all files, emails, recorded phone conversations, body camera recordings, text messages, and any other communications between lacey township school officials, board members, the lacey police department, the Los Angeles Police Department and any legal representation regarding Jonathan Lipman. At the least, under the laws, I seem entitled to everything regarding Jonathan Lipman's mental health starting on December 8, 2020, beginning at 4:06 PM EST. Let it be noted all discussions and decisions regarding myself by anyone in Lacey township following first contact regarding the lawsuit months ago affect my mental health. But at the least, I am entitled to all the information shared and discussed following third party claims of my lack of psychological well being that informed the decision to remove my civil rights under a patient health basis.

When it comes out I was held for more than 60 hours before EVEN TALKING TO a psychiatrist, it wont look like anyone was trying to help me.

Did Lacey Township really think the government officials of the city of Los Angeles were going to handle this well? Don't you all think this city is a disaster of misery that makes everything worse with its government?

Or were you trying to teach me a lesson? One needs to ask why you didn't include the entire chain of voice messages as part of your evidence against me. Or the email. Context is important don't you think? When you put the voice messages in order (and of course I have them) they tell a story. One you don't want people to hear. Crazy is a matter of opinion and perspective that few people are qualified to make. You don't want to make that claim lightly. Once you do, all the opinions and perceptions that people may have of that "crazy person" become an aspect of their mental health (and your claimed goal of its recovery).

Once again in one big runon sentence for the less educated: because of the events that followed a lawyer having her secretary send a generic email to a person claiming emotional trauma rather than treat that person like a human being who spent at least an hour dealing with her and her staff alone, that person, me, has a right to know the mental health perceptions of those who felt the need to take away ALL of their civil rights because IT IS part of their medical patient history.

Let me remind you Lacey Township School's history on this issue of silencing by alternative and questionable means is not good. Your school system in 2007 silenced a jewish person by blaming him for cancelling the Christmas special and holding his free speech hostage (ask will zyl) until he agreed not to be on live television again. His Vice principal disagreed with that decision.

But a jew was shamed by being blamed for cancelling christmas for 3 days and he suffered trauma from that in and of itself. Can you imagine how many people called me a jew or a kike over the fact me saying "I'm opp" justified William Zylinski's very real and believable threat to cancel about 50 peoples hard work by preventing the release of their christmas video projects? Can you imagine what blaming that jewish person under ridiculous circumstances for three days did to him? Can you think of why he might have referred to himself as "other peoples' property" rather than Jonathan Lipman on a live school program about 1700 students and teachers were supposed to be watching?

Look at the circumstances of the termination of the first telecom teacher. Your tactics in silencing people were documented over a decade ago numerous times so this latest attempt comes as no surprise. It is just proof the lawyers claims of doing things the right way and changing your ways from times past is nothing but a self serving lie.

Of course, anything I send you from this point will be reviewed by your lawyer and I'm sure there will come a point when she attempts to silence a victim of your system for speaking up against it. All I can say is you better be willing to put a former straight A student in jail for speaking up against a school whose lack of protections of him drove him to gain 70 lbs and attempt suicide once he left the school and came to terms with all he went through and the effect it had on his ability to socialize.

At this time, I have left about 12 messages with staff members in the high school. I will continue to loop in more people into your cone of silencing victims until I am able to review all your findings and all the documents you have related to Jonathan Lipman.

THIS IS MY FORMAL REQUEST FOR EACH AND EVERY DOCUMENT RELATED TO JONATHAN LIPMAN. Redactions of other students are fine as my memory will fill in those details. But as a victim of the lacey township system, I have a right to them as the person they involve.

THIS IS ALSO A FORMAL REQUEST FOR ANY AND ALL FINDINGS IN THE SUPPOSED INVESTIGATION THAT LED THE LAWYER TO DECIDE SENDING A KID HOME WITH NO CLOSURE AFTER A VIOLENT HATE CRIME WAS HANDLED APPROPRIATELY. I WOULD LIKE TO SEE HOW THE LACEY TOWNSHIP SCHOOL BOARD FULFILLED ITS STANDARDS AS EDUCATORS AND PEOPLE RESPONSIBLE FOR CHILDREN AND THE LIVES THEY BUILD FOLLOWING LEAVING THAT SYSTEM. SO PROVE MY ERROR AND APPARENT DELUSIONS OF PAST. IF YOU PROVE IT, ISN'T MY CASE DEAD IN THE WATER?

Why would you want to force a former student in pain to retain a lawyer to the detriment of his financial and mental health if you have the findings for him to see already?

Lets just make this clear so that if there is an intelligent person on the school board who understands how the media works, they can reconsider how this has been handled. In 2008, a person held a knife to a student's throat in front of a still employed male teacher who stood there and did nothing. That male teacher watched silently as the victim begged for his life with nihilistic humor and self deprecation, because after years in Lacey Schools, the victim whose life was being threatened knew shaming himself was the only deterrent that ever worked against all those in the Lacey School System who had intimidated him due to his minority status. THIS FACT CAN BE PROVEN. The school never talked to that student to assess if it affected his state of mind. They never called the kids parents to warn them their son just suffered a serious trauma few people ever go through and many have committed suicide over in the past. There was no police report even though it warranted expulsion. And years later, when that student came to you and said it has been detrimental to his life, you had your lawyer try to trick that victim into ruining his case by providing a surprise deposition to your legal representative even after he made clear he wasn't after money. Just accountability and closure.

Screenshots, my recorded interview with Mrs. Dev, and the schools attempts to silence my message on social media and prevent their public from knowing this have all been documented. Ignoring me or denying me on the basis of litigation will only be proving the willingness to cover-up and subvert the legal system to protect your schools image. Mrs Dev was

pretty clear in her intentions regarding speaking with me and it's pretty obvious her paralegal intentionally misinformed me regarding the purpose of our phone call in an attempt to catch me off guard. So how your school handles victims claims is pretty clear. I never even turned down speaking with the school board. Lawyer was your idea. So I guess students and former students' mental health comes second to protecting your budget.

With all this in mind, I ask you, do you really think parents with students will approve of how you handled this? Because they are going to find out along with many other people in America. I don't need to sue you to get closure. I'm a writer living in Los Angeles who can literally find funding from some trump hating liberal who wants to have a beach vacation at the shore and film a movie during summer break about bigoted conservatives in a town still able to practice segregation through alternative means. It will not be hard to use my story and your system to make a mockumentary about my pain and your incompetence. As it's a true story, good luck trying to silence me. Just be aware that eventually you will find yourselves needing a lawyer with a knowledge of the first amendment rather than one who decides the merits of a person's pain.

As people with past problems with lawyers, I recommend you don't be so sure you are adequately being served because the law firm has a respected name. Maybe you just wanted to save face and it's all about the name rather than the product received by the expensive law firm. But that's your mistake and only continues to demonstrate your incompetence.

Your lawyer seems to assume I'm some unemployed bum desperate for cash. But what if I'm not!? What if I'm actually pure. You could be receiving terrible advice. Or worse, all this may end up proving lawyers aren't your school's problem; just the people running it. So I recommend if you haven't done your own investigation free from a law firm using an application on a computer to determine risk factors regarding human people, you do it and share the former student whose pain you ignored.

If I do not receive these documents you will in fact be proving your willingness to cover up a former student's pain so it's in your best interest to show me exactly how you handled a knife to my throat accordingly. With evidence. Prove I'm some crazy opportunist looking for a handout who didn't suffer hate crimes and wasn't involved in a cover up to protect the schools image. Shouldn't be hard considering the letter Mrs Dev sent me. Sounds like she was thorough.

I ask you to realize that I can do a lot more with a camera than with a million dollar settlement. AND I WILL. At the expense of a town founded on discrimination and intimidation of minorities.

I was really hoping to be disproven and shown that the school took this seriously. I'm not out to harm people. I'm out to help the people who get ignored. I couldn't care less how this affects all the people in Lacey township who distract themselves from others pain with their own middle class privilege. But I'm not out for retribution to those who ignored my pain. I'm just doing what I believe is necessary to help whoever is Lacey Townships next [REDACTED] name a few.

You will receive one more email from me with a detailed statement regarding my time in the lacey township school system and its effect on me twelve years later. Do with it what you will but it will be published for your town to see and assess whether or not your system is the safe and welcoming environment your incompetent lawyer who holds money above all is claiming.

This is a peaceful protest for all the kids whose pain you ignored in an attempt to force them to submit to the wills of your town's outdated social views.

You have until the holiday multiple teachers used to shame me as a Jew. Gotta love Mrs Elias and her born again friends who made me contemplate suicide as a 6th grader "for my hellbound soul".
