1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On April 2nd, 2025 at approximately 2119 hours I was dispatched to 1328 River Ave (Burger King) in reference to a disorderly persons call. Upon arrival I spoke with the assistant manager of the Burger King who was identified as Julio Gonzalez. Mr. Gonzalez stated that the subject (Jose Heladio Bonilla Sanchez) came into the store and was heavily intoxicated. While speaking with Jose, he attempted to flee the area and resisted arrest by moving the officer's hands off of him. Jose was then escorted to the ground and taken into custody. Jose was transported to 231 3rd St. (Lakewood Police Department). While at the Lakewood Police Department, Jose was not compliant with police commands. Jose also made suicidal remarks saying how he wants to harm himself while speaking with officers. Jose was then placed into a holding cell. It was then noticed that Jose had an item in his hands, which was not allowed while inside of the cell. While attempting to remove the item from Jose's possession, he became violent and attacked two police officers and was then placed under control and transported to Monmouth Medical Center, Southern campus to be evaluated by PRESS.
