Tracy, Hope all is well. As you may recall we meet when you were the Municipal Prosecutor of Hoboken and I was the Municipal Judge of Weehawken. I live in Saddle River and seek your help with a County issue.

My house is on the Saddle River and in April of this year, a large tree fell from the other side of the river and is lying across the entire river. When I contacted the the Town Administrator, he advised me that since the Saddle River is Bergen County land, it was the County's responsibility to remove the tree. He said he would contact the County and have them come out to the property.

Since that time, despite numerous calls to the Town, no one has done anything and the tree is accumulating debris that flows down stream.

As a Freeholder, could you review this and have the proper county agent call me directly.

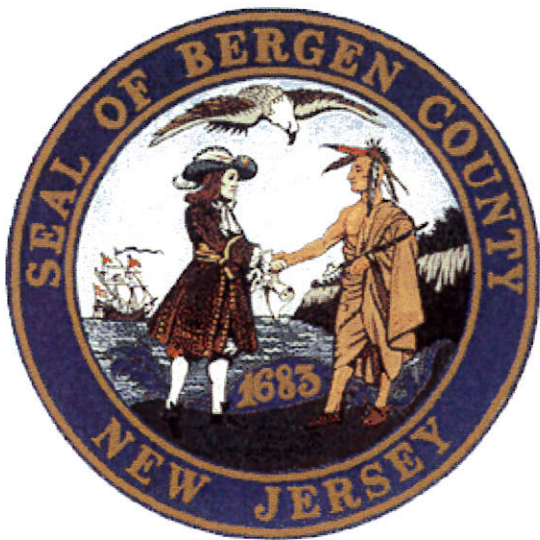

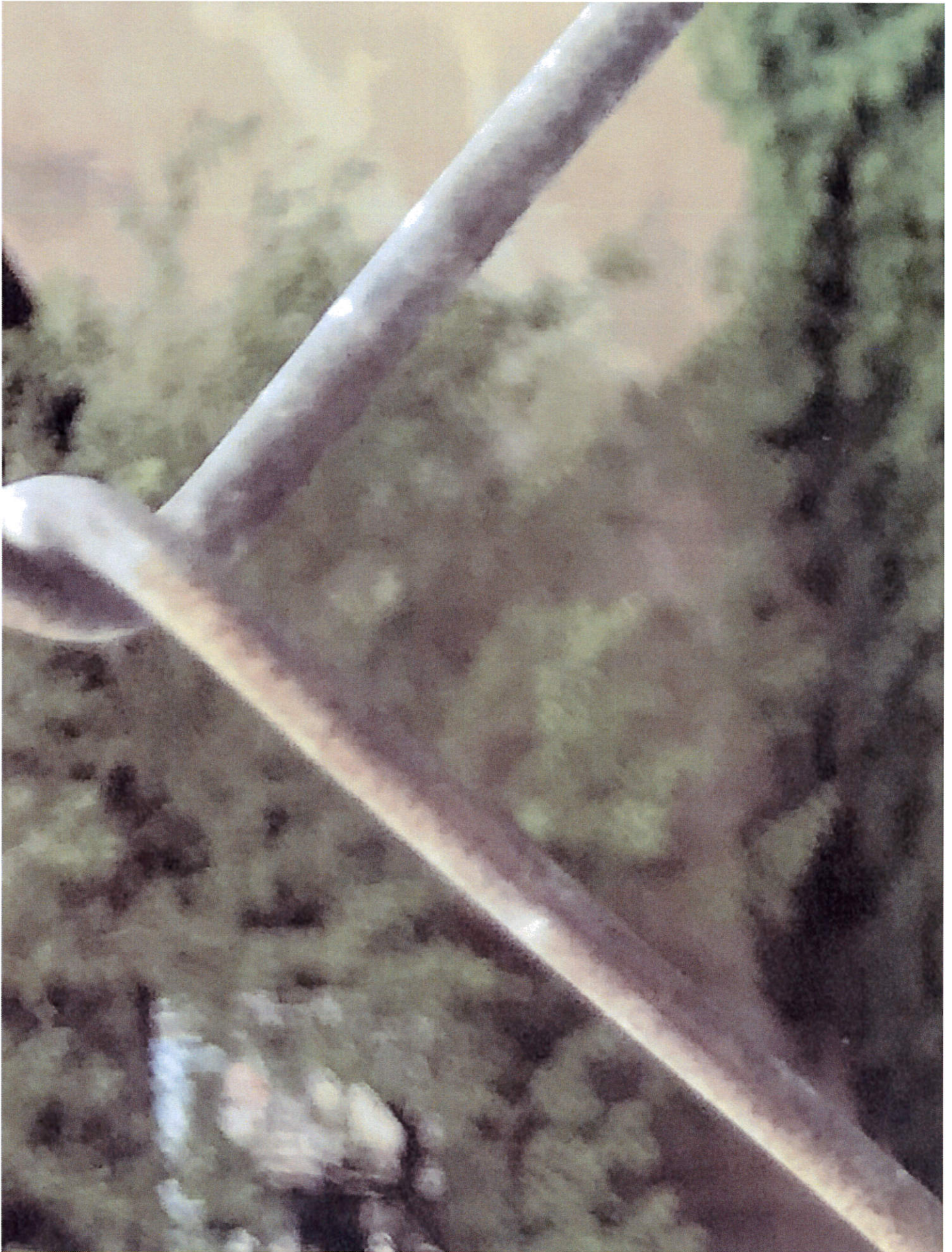
