This writer received a telephone call from Judge Mara Zazzali-Hogan, JSC regarding this bench warrant. Judge Zazzali-Hogan advised me that she wanted Mr. Sauter brought before her court prior to posting bail.

Mr. Sauter was subsequently escorted to Judge Zazzali-Hogan's courtroom by Lieutenant Steve Cooper and myself.

Mr. Sauter was processed and detained at the sheriff's office pending a court hearing before the Honorable Mara Zazzali-Hogan, JSC.

During the court hearing, the Judge ordered Mr. Sauter to turn over \$5,000.00 cash to the plaintiff, Ms. Regina Laffey. The undersigned handed the monies over to Ms Laffey. The plaintiff acknowledge receipt, verified the amount and wrote out a receipt to be turned over to Mr. Sauter.

Judge Zazzali-Hogan acknowledge the transfer on the record, vacated the bench warrant and ordered that Mr. Sauter be released from custody.

Ms. Regina Laffey reported to the sheriff's security office at the Monmouth County Courthouse (71 Monument Street Freehold, New Jersey 07728) on December 13, 2013 at 1503 Hrs to make a report on an incident that had occurred earlier today in Judge Mara Zazzali-Hogan, JSC courtroom (Room 128S) during a family court case.

On December 13, 2013, at approximately 0950 Hrs, Ms. Regina Laffey and Mr. Kevin Sauter appeared before the Honorable Mara Zazzali-Hogan, JSC on a family court case, docket number FM 13-1077-11D.

Mr. Sauter had surrendered himself earlier that day on a family court bench warrant that was issued by Judge Zazzali-Hogan on 12-11-2013 for failure to comply with court orders. Mr. Sauter was in court before Judge Zazzali-Hogan as a result of the execution of the bench warrant.

Present in the courtroom was Mr. Sauter's current wife, Susan Sauter (Last Known Address: 344 South Blvd Spring Lake, New Jersey 07762). Ms. Susan Sauter had accompanied her husband, Mr. Kevin Sauter when he surrendered himself at the sheriff's office that morning.

Ms. Laffey stated that when she was in Judge Zazzali-Hogan's courtroom, she was approached by Ms. Susan Sauter.

Ms. Laffey stated that Susan Sauter said to her " Hi Regina".

Ms. Laffey replied "Who are you?".

Ms. Sauter replied "Really?". When asked again who are you she replied "you know my address and wedding date". Ms. Laffey replied "that the information came from him (referring to Mr. Kevin Sauter)".

The hearing commenced and Judge Zazzali-Hogan took testimony from both parties (Regina Laffey and Kevin Sauter). Judge Zazzali-Hogan took a short break from the bench in order to contact two attorneys who were involved with "matters" associated with this family court case.

During that break, Ms. Susan Sauter moved up to the front bench, just behind Kevin Sauter and began speaking with him.

At one point, Susan Sauter leaned towards Kevin Sauter. Ms. Laffey stated that she heard Susan Sauter state " she looks the same..... beat the crap out of her.....get used to it".

Ms. Laffey stated that the statements made by Ms. Susan Sauter made her feel uncomfortable and that she (Regina Laffey) took that statement as a threat towards her.

Ms. Laffey does not want to file a criminal complaint at this time. She wanted to have this incident documented in a report.

Both parties, Regina Laffey and Kevin Sauter, are scheduled to appear back before Judge Zazzali-Hogan on Thursday, December 19, 2013 at 0900 Hrs.
