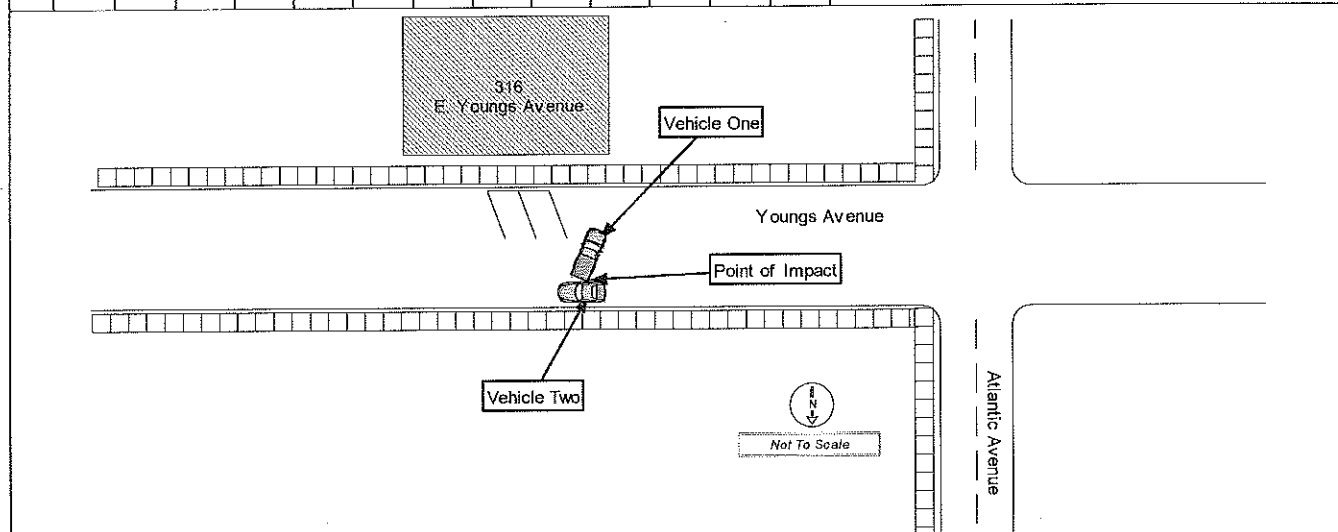

145. Crash Description/Narrative

*****Selective Insurance Co. of the Southeast, Carmel, IN 46032**

On Thursday June 14, 2018 at approximately 1659 hours, I, Ptlm John Dadura #83 of the Wildwood Police Department uniform patrol division, responded to the 300 East block of Youngs Avenue, for the report of a hit and run accident. Upon my arrival I spoke to the witness and caller, identified as Michele Lake. Lake stated she saw a dark gray pickup truck, bearing New Jersey registration AB1614, back from a parking space, into a Red Ford Mustang bearing Pennsylvania registration HWY4365. Lake stated the driver then proceeded West on Youngs Avenue, the wrong way on a one way street.

The Ford, vehicle two, sustained moderate damage to the passenger side of the vehicle. The passenger side door would not open. The door also sustained deep dents and scratches. The passenger side door window was shattered, and only held together by the windows tint
