**RE: OPRA Request dated April 8, 2021**

Dear Mr. Strunsky:

The Village of Loch Arbour received an Open Public Records Act ("OPRA") request from you on April 8, 2021 (see attached).

OPRA, however, only requires a custodian to provide records in response to those requests that clearly identify records and not those that are complex, overly broad in nature or require research by the custodian or staff. Accordingly, those requests by which you seek information and not records, are not subject to OPRA. The Village is also not required to create or compile a record to respond to an OPRA request.

Notwithstanding these objections, please find the attached responsive documents: The Village's Payroll Registers for 2019 and 2020, which contains the requested compensation-related information relating to the lifeguards.

Please note, if your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Village of Loch Arbour to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council ("GRC") by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at [grc@dca.state.nj.us](mailto:grc@dca.state.nj.us), or at their web site at [www.state.nj.us/grc](http://www.state.nj.us/grc). The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
