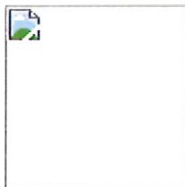

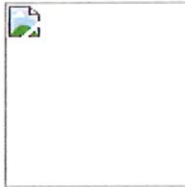

"TAX CLEARANCE

Be advised that your issuing authority has no jurisdiction to act on the renewal of a license, whether it is filed online or a paper filing, without first receiving an Alcoholic Beverage Retail Licensee Clearance Certificate for Renewal from the Division of Taxation. You are not expected to obtain the Certificate on behalf of the licensee, however you cannot act on the renewal without it. Please check your Garden State Portal Access for a listing of all licenses to determine if they are clear or not. License information is updated to the portal in REAL TIME.

NOTE: Questions regarding the Garden State Portal Access should be directed to the Division of Taxation at ABCClearance.Public@treas.nj.gov.

Please understand that it is the licensee who must be in tax compliance, therefore, if a clearance has not been issued it is the licensee's responsibility to call either their caseworker at the Division of Taxation or email Taxation at

ABCClearance.Public@treas.nj.gov. If a clearance is missing from the initial update, you should notify the licensee to contact their caseworker at the Division of Taxation or email Taxation at ABCClearance.Public@treas.nj.gov immediately."

Good afternoon Gerald,

According to the Division of Alcoholic Beverage Control (ABC) they have notified all Mine Hill Liquor License holders it is time to renew for the 2023-2024 Season. They have notified me that the Application for inactive Liquor License Number 1420-33-001-009 has not been applied for or paid for yet and has not received The Alcoholic Beverage Retail Licensee Clearance Certificates (also referred to as Tax Clearance) from ABC. If it has been 2 years since the license was inactive you may have to also complete the 12.39 Special Ruling Procedures.

I have been instructed by the ABC to "Contact all licensees who do not file an application or pay fees to notify them that failure to complete the filing of their 2023-2024 renewal application, municipal fee and state fee by **July 30, 2023** will cause their license to lapse. They will then be required to request a Special Ruling pursuant to N.J.S.A. 33:1-12.18 from the Director of ABC."

Since the Town Council needs to approve the liquor license renewal via a resolution the following need to be completed before the July 20, 2023 Town Council Meeting so that the resolution can be approved at said meeting:

- 1. Complete the renewal application online (Possibly complete the 12.39 Special Ruling Procedures if it has been 2 years since the last time requested or 2 years since license was inactive.**
- 2. Pay State fee**
- 3. Pay the Municipal Fee**

4. Receive tax clearance from ABC

ABC directed me this week on Monday afternoon:

"Should a licensee not have clearance, IMMEDIATELY contact the licensee and advise them you have not received their renewal clearance." (**I have not received the clearance for Liquor License Number 1420-33-001-009.**)

"Please advise the licensee that they can either:

Contact the caseworker they are currently corresponding with at the New Jersey Division of Taxation or; (attached is a listing of Supervisors in Field Offices)

They can reach out via email to the ABC Licensing Unit at: ABCClearance.Public@treas.nj.gov

Statuses will not be discussed with the Clerks."
