The Borough of Roseland received your Open Public Records Act (OPRA) request on April 19, 2022. The official Records Custodian, Jock H. Watkins, received your OPRA request on April 19, 2022. As such, the seven (7) business day deadline to respond to your request is April 28, 2022. This response to your request is being provided to you on the 1st business day following the custodian's receipt of said request.

The following records are being provided in their entirety and are responsive to your request:

1. Active Liquor Licenses [3 pages]

These records are being transmitted to you via email as per your request. Therefore, there is no cost associated with this request.

In addition to the records specified in your OPRA request, you also requested the following information:

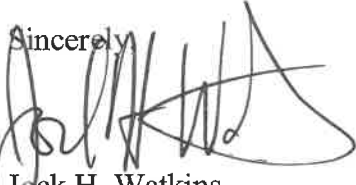
“Please provide the number of unallocated liquor licenses within the town, as well as the price to acquire them.”

This part of your request is a request for information, and is therefore not a valid OPRA request in that you have not named specifically identifiable records. This part of your request is therefore denied pursuant to the following court decisions: *MAG Entertainment, LLC v. Division of Alcoholic Beverage Control*, 375 N.J.Super. 534 (App. Div. 2005), *Bent v. Stafford Police Department*, 381 N.J. Super. 30 (App. Div. 2005), *New Jersey Builders Association v. New Jersey Council on Affordable Housing*, 390 N.J. Super. 166 (App. Div. 2007), and *Schuler v. Borough of Bloomsbury*, GRC Complaint No. 2007-151 (February 2009).

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Borough of Roseland to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (“GRC”) by completing the Denial of Access

Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The Council can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
