The City of Linden ("City") records custodian received your Open Public Records Act ("OPRA") request on December 1, 2023.

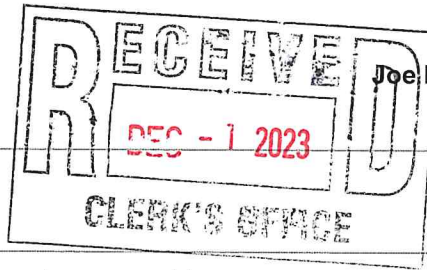
Your OPRA request seek the following records: See attached

- A list of all property addresses that the fire department has received an emergency call to in the last 90 days.
