The Department of Treasury, Division of Taxation, has reviewed your Open Public Records Act (OPRA) request C256464, in which you requested *"identifiable public records from the Department of the Treasury regarding the Sussex County Board of Taxation for the years 2006 through 2026 inclusive. Please provide the following - Annual Directories & Rosters: Copies of all annual directories, rosters, or master list logs maintained by the Division of Taxation (including the Local Property Tax Bureau) detailing the appointed Commissioners of the Sussex County Board of Taxation, including their specific statutory political party designations (Republican/Democrat) and term expiration dates for each year. Payroll & Compensation Records: Annual payroll certification logs, W-2 disbursement trackers, or ledger records showing state salary or compensation disbursements paid to all individuals serving as Commissioners, Board Members, or Administrators for the Sussex County Board of Taxation for each calendar year. Vacancy and Holdover Logs: Any internal tracking logs, memos, or electronic records identifying vacancies, unexpired terms, or individuals serving in an official "holdover status" on the Sussex County Board of Taxation during this timeframe."*

On behalf of the Records Custodian for the Division of Taxation, we are providing the following response. In response to the Annual Directories & Rosters part of your request, when the County Tax Board database is updated to reflect a new member, the previous member's information is replaced, and no historical record is retained. Attached are the following Sussex County records:

- Past Commissioners (2006–2026)
- Current Sussex County Tax Board Report
- Sussex County Education Reports (2010–2026)

Please note that the Division does not have education reports for 2006–2009, 2011, or 2017. The education reports provide a historical record of the board membership, although they do not include political party affiliation information.

The Division does not have payroll information for County employees. Taxation suggests you submit this part of your request to the County.

The Division does not send any kind of correspondence related to vacancies or holdovers nor does the Division have any internal memos or emails.

As such, OPRA Request C256464 has been closed.
