78. Narrative On 05/12/2024 at approximately, 1826 hours patrol was dispatched to Shoprite for shoplifting, that was not in progress. Upon arrival, patrol spoke with loss prevention, who advised the male individual has stolen numerous times from the Mansfield Shoprite and Flanders Shoprite. They advised in the past he has taken Coricidin cold medicine. Earlier in the day he took a Kombucha drink and Hamburger buns. They advised they approached the individual, to ask for him to pay restitution, but he ignored them and exited the store. He left in a Gray Nissan SUV with New Jersey registration T87SZH which comes back to a Cory Fleming out of Long Valley New Jersey. Patrol ran Mr. Fleming's driver license and confirmed the picture to match the ones of the male party from ShopRite. The total amount of all the thefts totals 32.35, due to the small amount ShopRite advised they did not want to pursue anything and just wanted to make us aware. They also advised if we made contact to have him sign a form that advises him, he is banned from numerous ShopRites. They also advised the individual came back into the store prior to patrols arrival but they were unable to locate him at this time. Loss prevention provided patrol with the video surveillance, and a bulletin with pictures of the individual. Patrol cleared.
