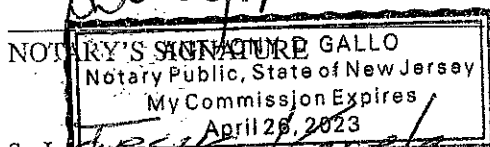

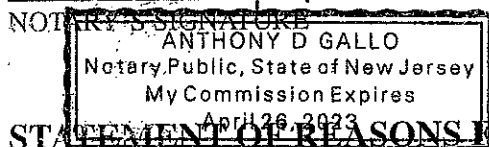

STATEMENT OF REASONS FOR THE RECALL

Since the three terms of office of Wilda Diaz, Mayor of Perth Amboy, our city of Perth Amboy has been plagued with her mismanagement, lack of transparency, and she has failed to successfully address our degraded water and sewer system, despite rising water fees to our residents. In addition, the residents of Perth Amboy have been recently exposed to dangerous contaminants in our Municipal Drinking Water. Wilda Diaz has previously denied problems with our drinking water, and did not attend two recent Public EPA meetings/presentations which showed contamination of three of our Water Wells located in Old Bridge, NJ.
