> I was just informed by the County Road Department that a routine inspection of the Broadway Bridge yesterday showed extreme deterioration of the piles under water, and they are posting the bridge to a 3 ton weight limit this morning, which is basically passenger cars only. They are adopting an emergency appropriation for priority 1 repairs, and stated that they will have to complete the repairs within the next 30 days. They are unsure at this point if the bridge will be closed during repairs. I will update you as I receive new information.
