A family issue, too

everyone impacted by heart disease at the seminar offered physically. "My mother, she was having a lot of problems with her heart," said Mary Alvarado, 60, who had open heart surgery. They changed the valves in her heart. "Unfortunately, the procedure was unable to save her life. She passed away two weeks after that. I rushed her to the hospital when she was having a heart attack, and then they found all the problems she was having. I don't know why they never found [those problems] before." Alvarado's mother also had thyroid disease, which increases one's risk of contracting heart disease.

Though Michele Matullo, 67, always did her best to keep a healthy heart, she almost fell into vices. One day, many years ago, she decided to light a cigarette, for reasons she still doesn't know. Problem was, she did it in front of her son.

"He was having a fit," Matullo, 67, said. "And he slapped it out of my hand. He just took it from me and he said, 'You're not smoking.' I was like, 'Okay, no problem.'"

She hasn't smoked since.
