Rinn also said in the letter that Moshe's application "expresses its commitment to the continuity of services in Hudson County." He noted that at a November meeting with the state health planning board, Moshe said that "the hospital has been a greatly underutilized asset and there's much more that can be done to enable it to achieve its full potential."

At that same meeting, according to Rinn's letter, Secaucus Town Administrator Gary Jeffas, on the town's behalf, spoke positively of the application to purchase the hospital.

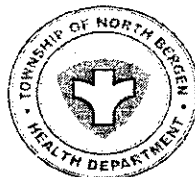
