They stated they had security surveillance of Jean Santana Rodrigues (Elton Valladares) stealing cash from registers he was tending from 5/3/2024 - 5/19/2024. They stated that they had confirmed \$1000.00 of missing cash, but the amount of stolen cash was much higher. Upon arrival I, Sgt Dinis, spoke with Home Depot Asset Protection, who stated that during their interview with their employee, he admitted to taking the money. Jean was then placed under arrest and searched incident to arrest. He was read his Miranda rights and stated he understood. While conducting a search of his person, he had in his wallet a NJ...

Drivers License belonging to Felipe Ortiz Sanchez. At first Jean stated it was his brother's DL, but through further investigation, Jean did not know who the DL belonged to and was told to just hang onto it by a friend. It was the only type of ID found in possession by Jean. Jean was handcuffed behind his back with the cuffs double locked and checked for proper fit. He was escorted out of the store and placed into the rear seat of patrol unit 206. The rear prisoner compartment was checked and free of contraband pre and post transport, as well as starting and ending mileage reported to dispatch. During processing and the investigation, Jean continuously used the name Elton Valladares with a DOB of 9/19/24. After being asked multiple times, and during fingerprinting, he revealed his "real " name of Jean Carlos Santana Rodrigues. He also stated he used that name, DOB, false SSN and false address for employment at Home Depot. He did not have a previous fingerprint or state ID on file for cross reference.

When asked about the theft, Jean stated he was sorry, but he had to take the money for his young daughter. I then asked him about why he was using the fake name and DOB, which he stated he was scared and it was because that is what he was using to get a job. He informed me that he is not a US citizen and that he made up the SSN and it worked for him in the past, so he continued to use it. I contacted our Zone AP who confirmed the charges of 2C:20-7a, 2C:20-3a, and 2C:29-3A(3). He charges were placed on S2024-000038. Jean was given a court date and released with out incident.

Store surveillance file, thumb drive containing security camera footage of Jean taking the money as well as the NJ DL seized was entered into the Beast Evidence system and stored in the locker.

On May 22, 2024 Leon, Home Depot asset protection employee, came to police headquarters to report a shoplifting that occurred on May 1, 2024. Leon reported to me (D/Sgt. Fama) that on May 10, 2024 a suspect later identified as Andre Banton (NY- 691017290) entered the store and selected a vanity off the display shelf. Banton proceeded to open the box and take the actual vanity out and left it in the aisle. Then Banton walked to the tool corral with the empty box on a flat cart and filled it with power tools. Banton then proceeded towards the exit doors passing all points of sale, failing to pay for the merchandise. Banton was able to exit the store and load the merchandise into the getaway vehicle (white Jeep Cherokee). The total amount of the merchandise is \$3715.00.

Later that evening a 2014 Jeep Grand Cherokee bearing NY registration KUB5567 was stopped in Roosevelt, NJ. When officers had the occupants step out of the vehicle Banton was identified as one of the three individuals inside of it. This is how he was positively identified. Banton was wearing the same hooded sweatshirt with the diamond logo on the chest, sandals and black Adidas pants with white stripes on sides.

I performed a criminal history search on Andre Banton and his last arrest was in 2023 out of Hazlet Township for shoplifting.

I typed summons complaint 1212 S-2024-000039 for shoplifting and mailed it to his last known address.
