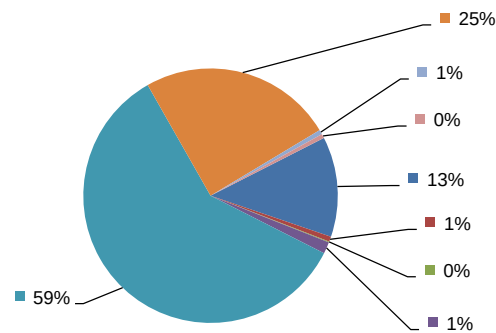
ASSESSMENT TRANSPARENCY - Total Assessed to Equalized Value
