78. Narrative
While on uniformed patrol assigned to marked vehicle 904, I was traveling on North Park Pl. and noticed a wrong way driver stopped at the intersection of West Park Pl. and North Park Pl. At this point, I initiated my overhead lights to conduct a traffic stop for the above listed vehicle.

I exited the vehicle, approached the driver, and instructed her to put the car in park. I could smell a strong odor of an alcoholic beverage emanating from her mouth. I then asked the driver to exit the vehicle, shut the vehicle off, and to give me the keys. I observed the driver was incoherent, hysterical, had a slurred speech, and was unable to obey my commands. I immediately called for backup after the driver was refusing to obey my commands. During this time, the passenger Paula Costa stepped out of the vehicle and attempted to enter the driver seat. I instructed Costa to step away from me and return to the vehicle. Costa was eventually escorted away from the vehicle by Sergeant LaFera onto the sidewalk. After numerous attempts to instruct the driver to park the vehicle, she was eventually guided out by Sergeant LaFera. Once the driver Ariene Ellefsen was guided out of the vehicle she was instructed to walk to the sidewalk, where the ground was level and clear of any obstructions, so a series of Field Sobriety Tests could be performed. Due to the driver's level of intoxication, pre-exit testing questions could not be conducted.

During Ellefsen's exit she appeared unstable on her feet and was staggering, swaying, and utilizing the light post for

support. Ellefsen was crying hysterically, begging for help, and incoherent when speaking with her. While outside the vehicle I could once again smell a strong odor of an alcoholic flavored beverage emanating from her breath. I asked Ellefsen where she was coming from today and she advised Brazil and then from New Providence, since she advised she lives in Summit. I then asked Ellefsen how many drinks she had tonight, and she was unsure, but advised she drank wine with her friend Paula. Ellefsen's eyes were bloodshot and watery, and her speech was slurred. Further investigation revealed Ellefsen had left from The Laundromat Bar.

Prior to conducting the walk and turn test, I demonstrated to Ellefsen the proper starting position and how to properly conduct the test. During this time, Ellefsen advised she did not understand my instructions and began to move prior to advising her to begin and utilized the parking meter for support. When I instructed Ellefsen to begin, I observed her take 3 steps forward while holding on to the parking meter and did not count out loud. At no point did her feet touch heel to toe. She then began to lose her balance and stopped. I observed Ellefsen to begin swaying and having difficulty keeping her hands to her sides. Ellefsen could not complete the test due to her lack of balance and incoherent state. At no point did Ellefsen count out loud and she also had her arms raised more than six inches during the test.

One Legged Stand Test: The undersigned read the instructions and demonstrated how to properly conduct the test. I observed Ellefsen to be unsteady and swaying while listening to instructions. During the test, I observed Ellefsen to not follow directions at all. She did not count out loud or keep her hands to her sides and was once again unable to perform the test, due to her incoherent state. During my instructional phase I observed Ellefsen immediately become hysterical and beg for help.

Based on my training and assistance from senior officers, along with observations during the investigation and her SFST (Standard Field Sobriety Test) performance, Ellefsen was placed under arrest for driving while intoxicated. Ellefsen was placed in double locked handcuffs and searched incident to arrest for contraband yielding negative results. She was then placed in the rear compartment of vehicle 904 which was searched pre and post transport for contraband yielding negative results.

PO Hanley stood by with the vehicle and waited for C&L Towing to arrive to impound the vehicle.

Once at 200 South St., PO Mazza read the NJ Attorney General Standard Statement for Motor Vehicle Operators, and when asked if she would provide breath samples, she advised she would. PO Mazza assisted with the Alcotest instrument and advised after three attempts; Ellefsen was a refusal. She was then processed, fingerprinted, and then placed in cell five. She was later released to a sober party Eric Ellefsen who read, acknowledged, and signed the Potential Liability Warning (John's Law) paperwork. She was advised of her mandatory court date of June 3, 2024, at the Morristown Municipal Court at 1600 hours.

Narrative While on uniformed patrol as the traffic safety officer in marked vehicle 901, the undersigned was patrolling CR-617 when I observed a Nissan X-Terra bearing registration F35RHH NJ stopped in the lane of travel on Speedwell PI with hazard lights on. I then positioned vehicle 901 and activated my BWC behind F35RHH NJ in an effort to investigate why the vehicle was idling without need at nearly 0130hrs. As the idling time grew and I could still see no rational explanation for the position of F35RHH NJ, I activated vehicle 901's emergency lights and conducted a traffic stop. Upon my approach I observed F35RHH NJ's operator, later identified as Rigoberto Cabrera-Velasquez, asleep behind the wheel with the ignition turned on and his right hand grasping an open 16oz bottle of Modelo alcoholic beer. This prompted me to radio for back-up units. I then woke Cabrera-Velasquez up and I identified myself as a Morristown Police Officer, advised him of his traffic violation(s), and I observed obvious signs Cabrera-Velasquez was intoxicated by his glassy and bloodshot eyes as well as the strong odor of alcoholic beverage flavorings emanating from the vehicle. Due to this fact-pattern and the impending threat to public safety, I next ordered Cabrera-Velasquez to turn his vehicle

off and step out for further investigation and standardized field sobriety testing. I also requested Cabrera-Velasquez' driver's license, vehicle registration, and proof of insurance which he slowly fumbled with. It should be noted at least three additional open six-packs of Modelo alcoholic beer in the rear seat area of F35RHH NJ were observed while I awaited Cabrera-Velasquez documents. Upon receipt of the documents, I then guided Cabrera-Velasquez to the front of his vehicle as he re-questioned what happened (although I already provided this information) and Cabrera-Velasquez explained he was simply dropping a friend off at the current location. Cabrera-Velasquez then nearly fell over in the roadway, his speech intermittently slurred, and I inquired if he was able to count 1-100 and 100-1 and he responded positively. I then asked Cabrera-Velasquez to count back from 57 to 34 without stopping and he altered his mind and advised he could not do it. Cabrera-Velasquez appeared to be adamant that because he was only dropping a friend off on Speedwell PI that it was ok that he was driving. When questioned, Cabrera-Velasquez admitted immediate operation to F35RHH NJ via taking his friend from Cabrera-Velasquez' residence of 35 Martin Luther Kings Ave to Speedwell PI about "5 minutes or 10 minutes" ago and used this to justify his use of hazard lights. Cabrera-Velasquez still appeared confused per why he was stopped, and he was again re-advised; and he admitted to consuming some of the beer observable through the windows of F35RHH NJ. I then felt it necessary to send for a Spanish-speaking officer, Morris Township P/O Palacio #172, to assist with my investigation to ensure Cabrera-Velasquez understood what I was telling him. The scent of alcoholic beverage flavorings was now detectable immediately from Cabrera-Velasquez' breath and when asked how many beers he drank; Cabrera-Velasquez responded 6. Standardized field sobriety testing then began. P/O Grawehr #190 attempted to conduct the first test of Horizontal Gaze Nystagmus in English. Cabrera-Velasquez refused to comply with the test instructions in English and either moved his head or would/could not follow P/O Grawehr's stimulus properly. Cabrera-Velasquez then became emotional and advised patrols physically and verbally that he had his hazard lights on suggesting he thought this gave him a cloak of invincibility. Upon Morris Township P/O Palacio #172's arrival, the Horizontal Gaze Nystagmus test was re-administered translated into Spanish and Cabrera-Velasquez still could not comply with the simple instructions although he advised he understood them. Due to Cabrera-Velasquez' non-compliance, no clues were observed (Decision Point = 4). This became a moot point and I moved on to the next assessment. I next conducted the Walk-And-Turn test with Morris Township P/O Palacio #172 translating for me. An unobstructed piece of sidewalk was used to conduct this assessment. I scanned a notepad to provide instructions for this test and I demonstrated them; and Cabrera-Velasquez appeared confused by these simple instructions but advised he understood the directions. I observed the following clues during this test: Cannot keep balance during instructional phase, starts before instructions are finished, stops walking to steady himself, does not touch heel to toe, loses balance while walking, uses arms for balance, turns incorrectly (no turn made), and incorrect number of steps (20 consecutive steps in-line) (Decision Point = 2). I last conducted the One-Leg Stand Test with Morris Township P/O Palacio #172 translating for me. Here again, I scanned a notepad to provide instructions for this test and I demonstrated them; resulting in Cabrera-Velasquez telling me to count for him while he was holding his leg up. Ultimately Cabrera-Velasquez advised he understood the directions. I observed the following clues during the test: sways while balancing, uses arms to balance, hopping, and puts foot down. (Decision Point = 2) Due to the totality of circumstances observed, the undersigned placed Cabrera-Velasquez under arrest in double-locked handcuffs to the rear for suspicion of 39:4-50 DWI, searched him, and transported him to the Morristown PD in vehicle 901 for Alcotest procedures. Cabrera-Velasquez' vehicle F35RHH NJ was also searched for intoxicants yielding positive results (mentioned and confirmed from above) and ultimately impounded at C & L Towing for a 12-hour minimum. Vehicle 901 was checked for contraband before and after prisoner transport yielding negative results and a check through NCIC/SCIC revealed no holds or warrants for Cabrera-Velasquez. Upon arrival at Morristown PD, Cabrera-Velasquez was played the N.J. Attorney General's Standard Statement for Motor Vehicle Operators in Spanish found on the NJ State website and complied to undergo Alcotest breath test sample procedures. Alcotest operator Morris Township P/O Palacio #172 then began a 20-minute Alcotest observation window which ultimately ended with breath samples yielding a BAC of 0.17% under sequential file #01548 (checked through dispatch for tolerance). Cabrera-Velasquez was then processed and he contacted a sober party for
