This request is hereby denied as these documents are protected from disclosure pursuant to N.J.S.A. 47:1A-9 which upholds exemptions contained in other State or Federal statutes and regulations, Executive Orders of the Governor, Rules of Court, Constitution of this State, or judicial case law. The specific statute which exempts the requested records from disclosure is N.J.S.A. 34:15-128.

- All documents pertaining to Jeffrey Profitt and Joseph Dixon's field training by MPD

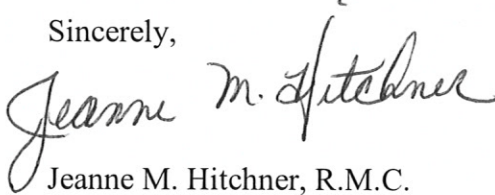
These records have been provided without redactions for Joseph Dixon. There are no records responsive for Jeffrey Profitt.

At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at (866) 850-0511, by mail at P.O. Box 819, Trenton, NJ 08625, by e-mail at grc@dca.state.nj.us, or at their website at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
