

**Agreement to Renew Membership in the

3. TOWNSHIP OF CLARK agrees to be a participating member of the FUND for the period herein provided for and to comply with all of the rules and regulations and obligations associated with said membership.
4. In consideration of the continuing membership of TOWNSHIP OF CLARK, the New Jersey Municipal Self Insurers' Joint Insurance Fund agrees, subject to the continuing approval of the Commissioner of Banking and Insurance to accept the renewal application of TOWNSHIP OF CLARK.

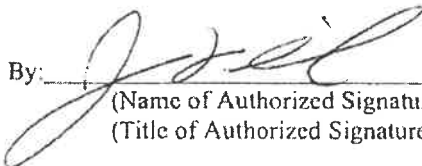

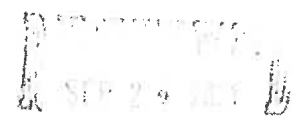
