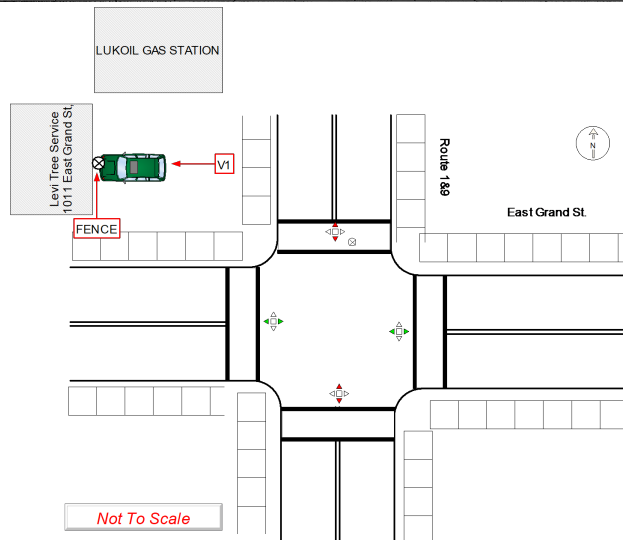

BWR utilized.

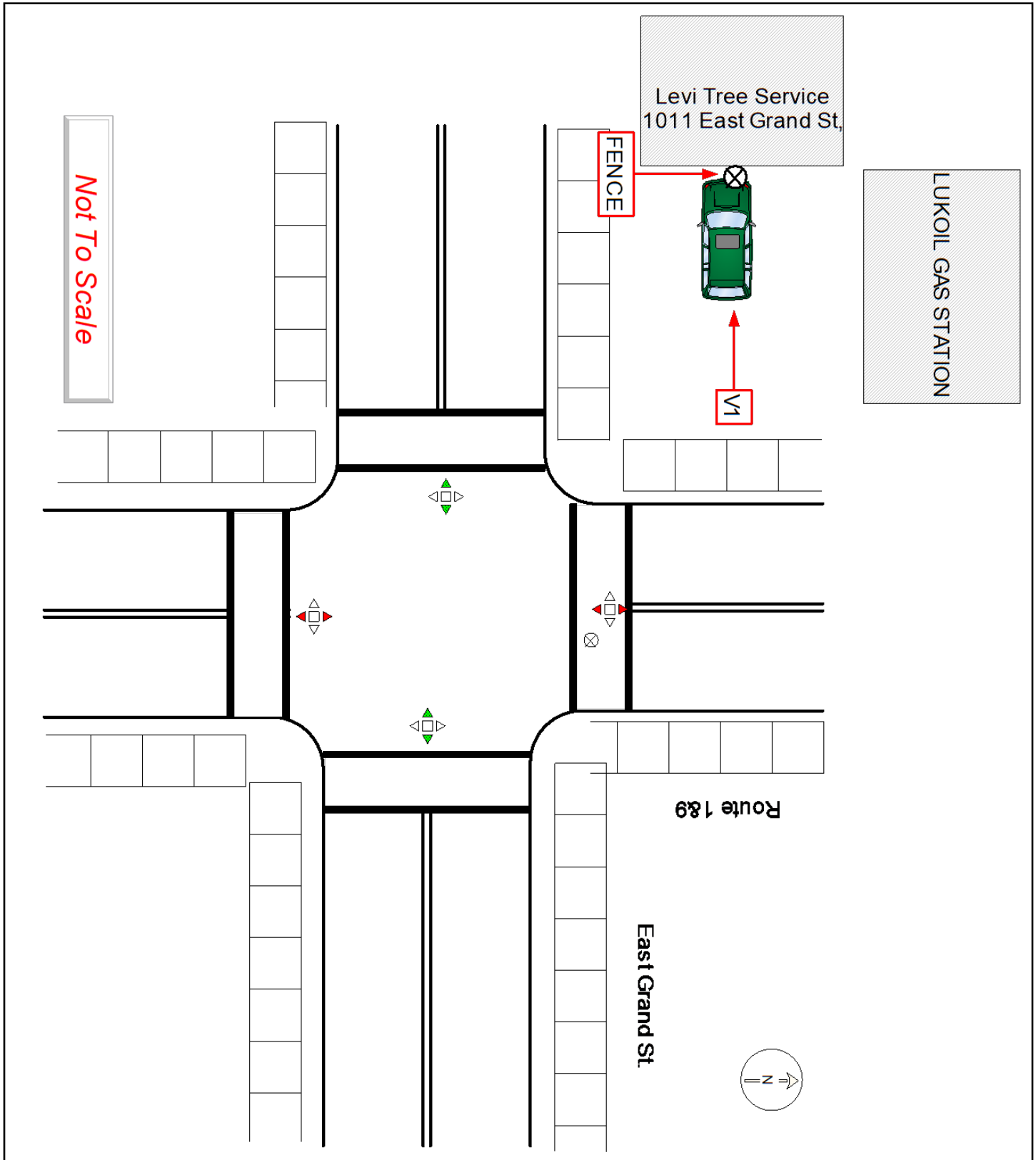
