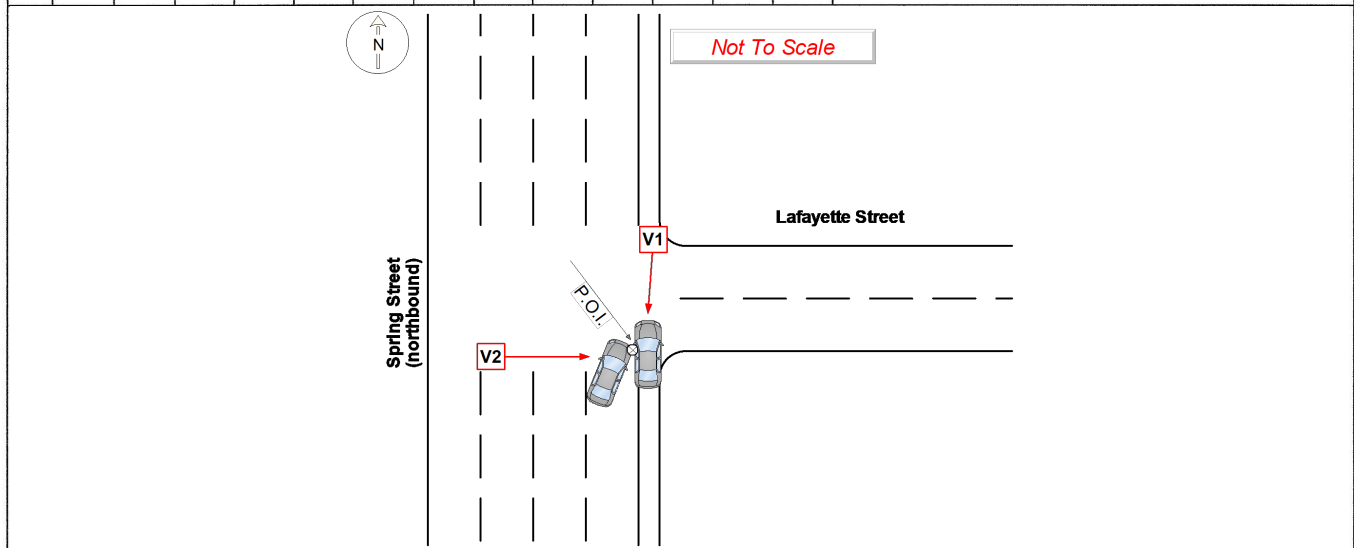

145. Crash Description/Narrative

Driver 1 stated she was traveling on Spring Street northbound "in the far right lane" passing Lafayette Street. Same stated this is when Driver 2, who was traveling in the lane to the left of her conducted a right hand turn and collided into her. The damage to Driver 1's vehicle was to the front drivers side door.

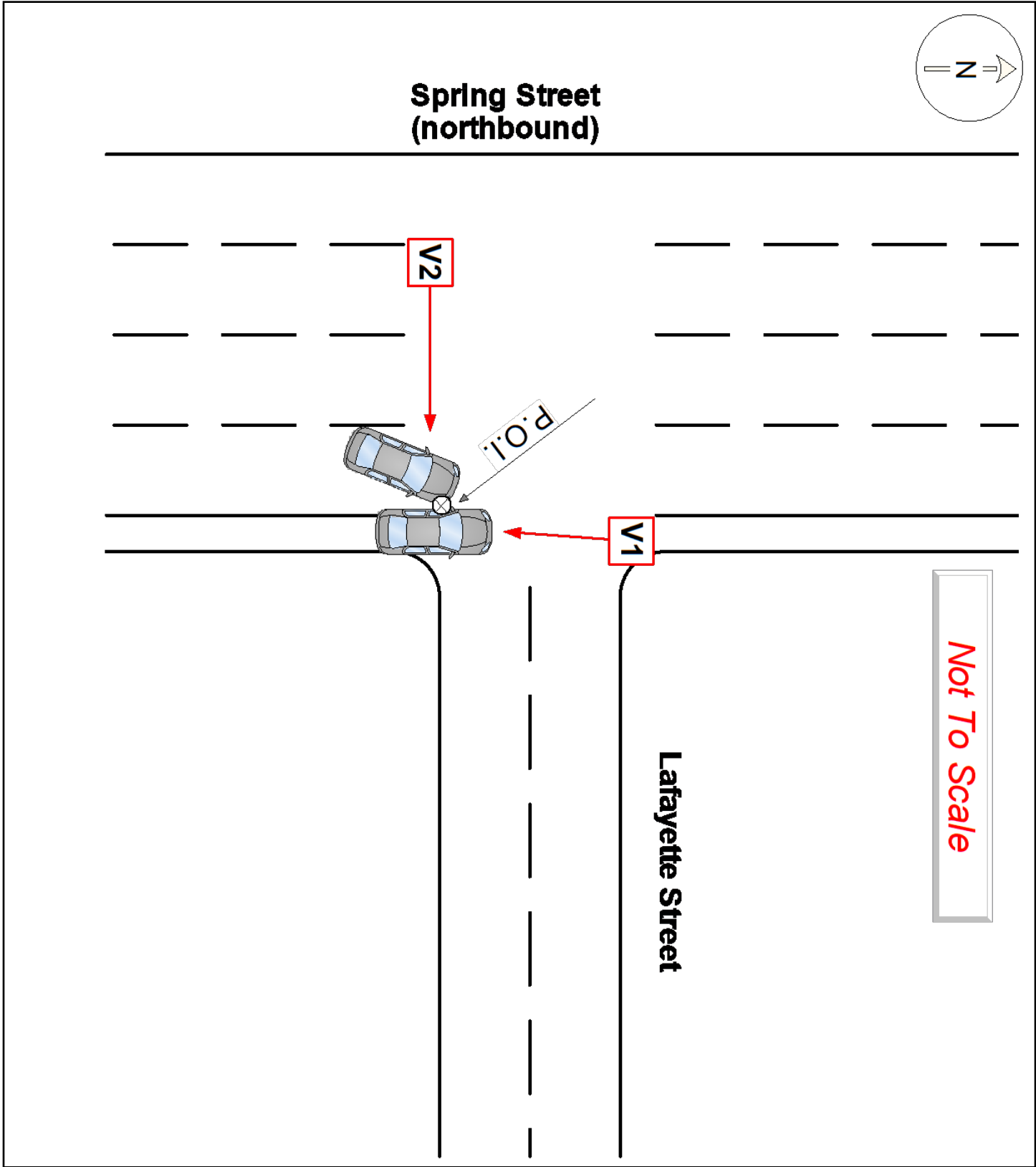
Driver 2 stated that he was traveling on Spring Street northbound in the far right lane. Same stated as he was conducting a right hand turn onto Lafayette Street, this is when Driver 1 who was traveling in the shoulder lane was passing him. This caused Driver 2 to collide into Driver 1. The damage to Driver 2's vehicle was to the front passenger side quarter panel.

All parties refused medical attention at this time. All parties were advised accordingly.
