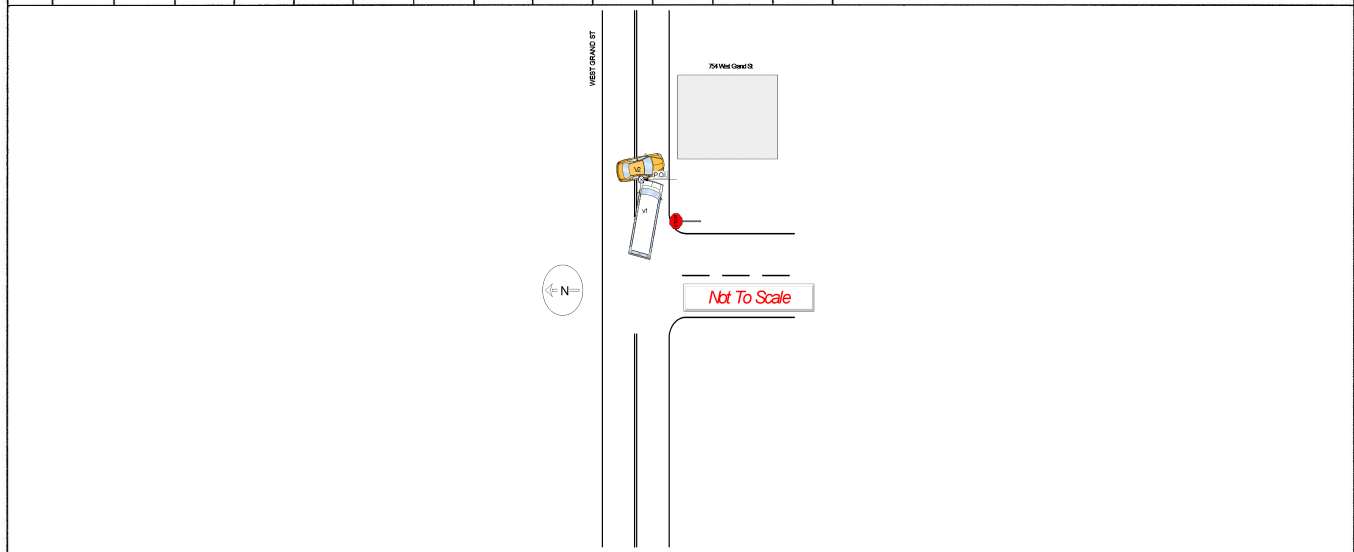


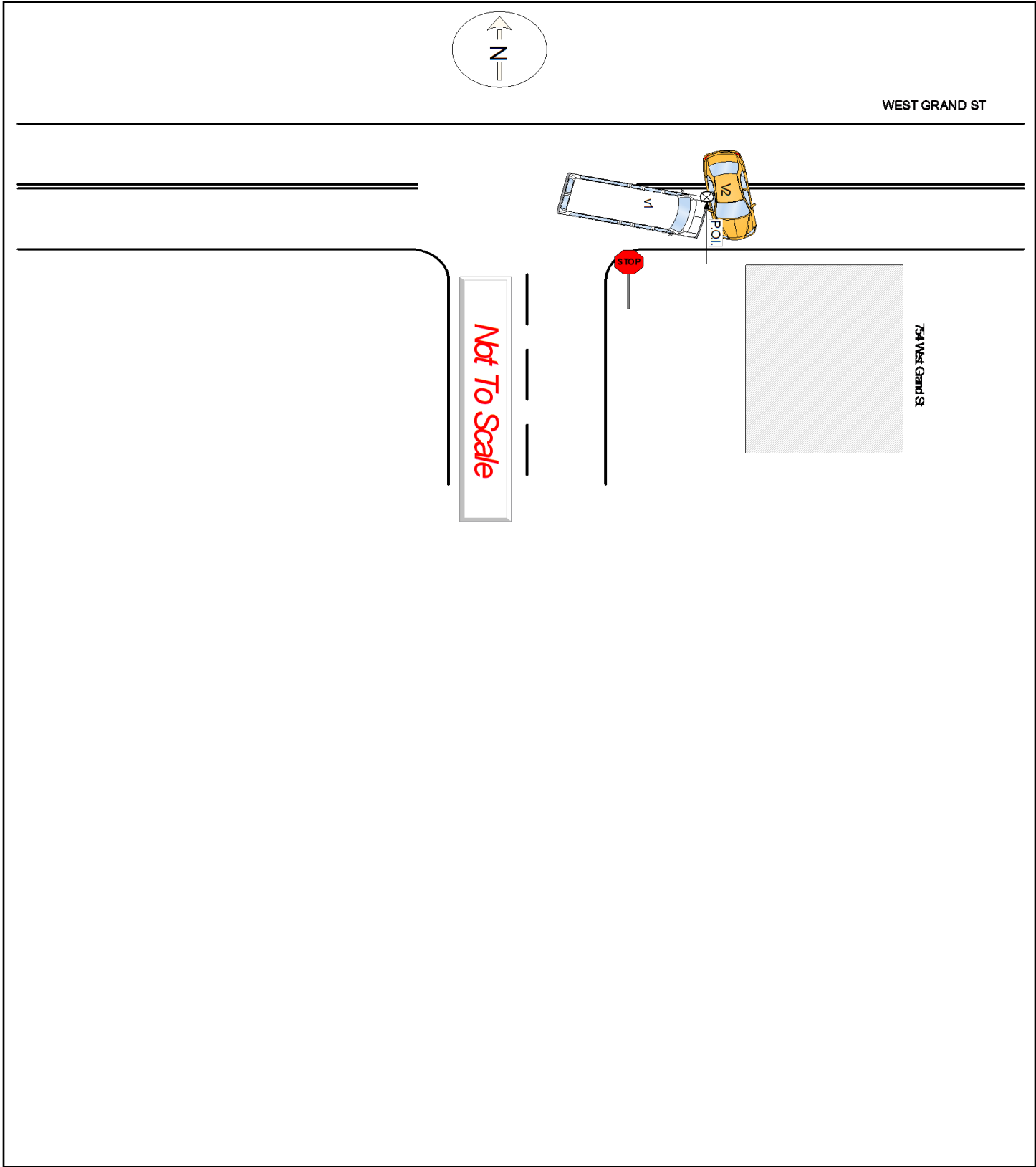

145. Crash Description/Narrative	
<u>Driver 1 stated he was traveling east on West Grand St when vehicle 2 (which was traveling west) abruptly made a U-turn in front of 754 West Grand St. This action caused vehicle 1 and vehicle 2 to collide. Driver 1 stated he immediately stopped. Driver 1 stated that vehicle 2 pulled over, 2 female passengers exited, after that vehicle 2 fled east on West Grand St. Driver 1 was able to obtain the plates on vehicle 2 NJ H10-I EM (03 Gold BMW).</u> <u>Vehicle 1 sustained damage to the driver's side bumper, and corner panel.</u> <u>Driver 1 complained of pain to his back but did not want to be checked by EMS at this time.</u> <u>The passengers in vehicle 2 stated that the registered owner of the vehicle was driving and attempted to make a u-turn which caused the accident. They stated that he pulled over, they exited the vehicle and he fled. Vehicle 2 sustained an unknown amount of damage to the passenger side.</u> <u>Driver 2 was issued the following tickets:</u> <u>2004 E20 009750 "Reckless Driving" 39:4-96</u> <u>2004 E20 009751 "Careless Driving" 39:4-97</u> <u>2004 E20 009752 "Leaving the scene of accident" 39:4-129A</u> <u>All parties advised accordingly.
