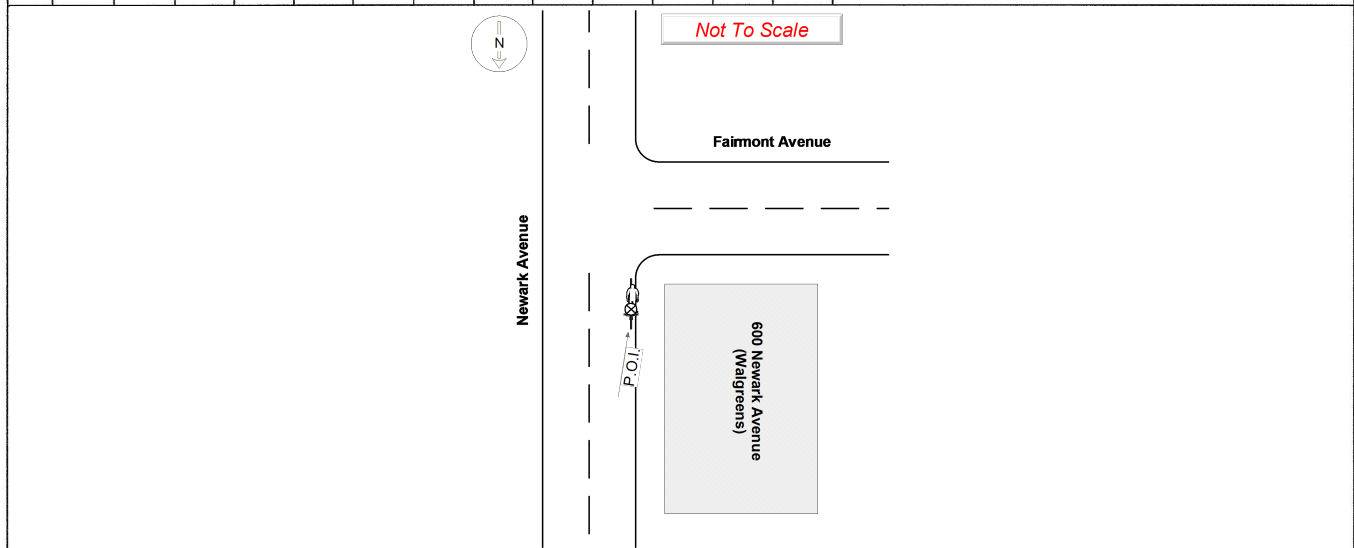

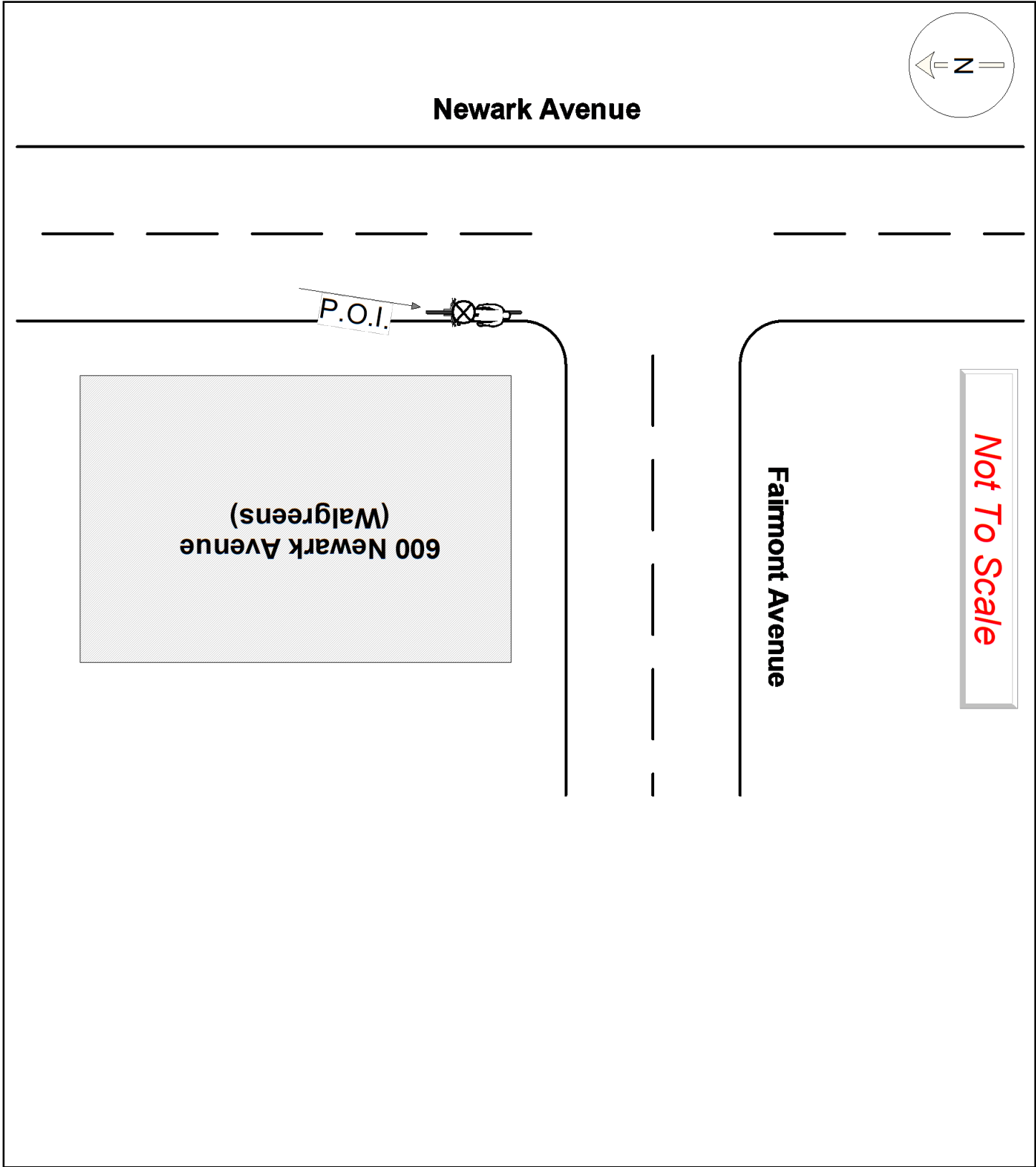
145. Crash Description/Narrative

On April 1, 2020 at 18:52 hours, Power 4 Sierra (Officer V. Valdez V958) and I (Officer C. Dalziel) were dispatched to 600 Newark Avenue (Walgreens) for an Auto Pedestrian. The victim, later identified as Lamar Blackney, made his way to the intersection of Newark Avenue and Waverly Place where EMS 7 was on scene and assessing his injuries. Upon our arrival it appeared that Lamar had suffered an injury to his right leg. It should be noted that Lamar was intoxicated and very combative with EMS while attempting to assess his injuries. In the ambulance I asked Lamar what had occurred, but he could not give a clear statement. Lamar did state that he was near the Walgreens when a vehicle struck him on his bicycle. Lamar could not give a description of the vehicle that struck him, which way the vehicle was traveling when he was struck, how he was struck, or which way the vehicle fled. Also in the ambulance Lamar continued to be combative and refused any further medical attention. Same then walked off of the ambulance willingly. Lamar was advised accordingly.
