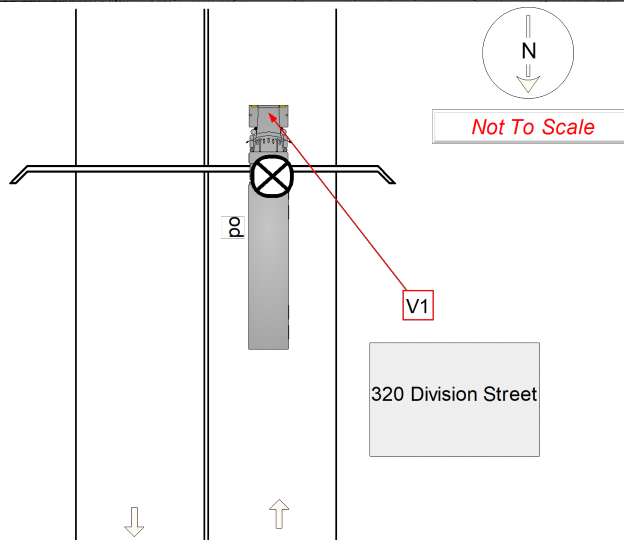

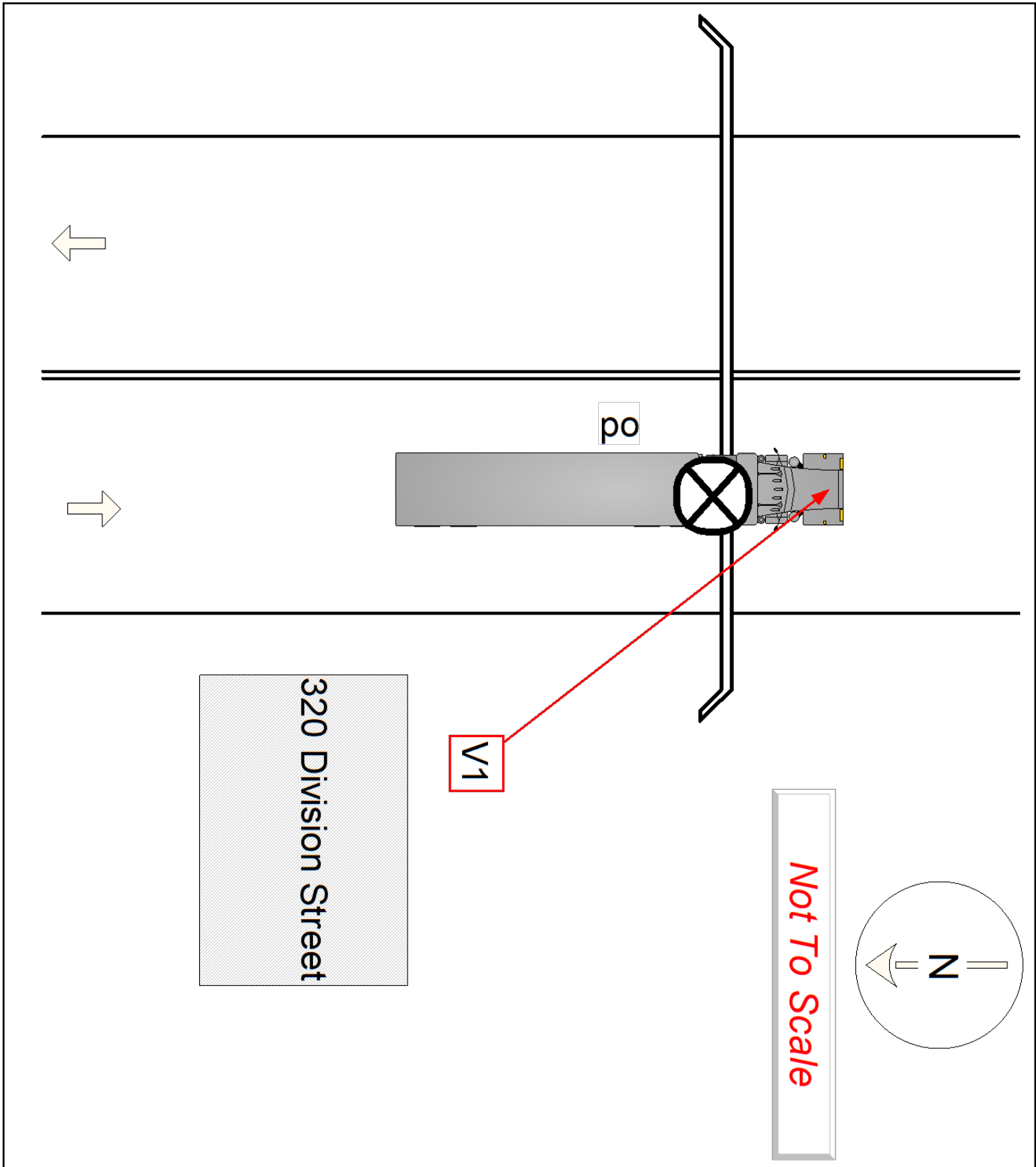

145. Crash Description/Narrative

Driver of Vehicle 1 stated he was traveling southbound on Division Street towards Trumbull Street, following his GPS. It should be noted vehicle 1 is a Tractor Trailer with cargo located inside vehicle. Vehicle 1's trailer struck the bridge located above Division Street, in between Magonlia Avenue and Trumbull Street. Highway Towing arrived on scene in order to remove the cargo from inside the trailer and remove the trailer from under the bridge. Both the trailer and the actual truck were both towed by Highway Towing to their garage. The trailer caused minor damage to the bridge, however approximately half of the trailer's roof was torn off. Ticket number 2004 E20 009767 was issued to the driver (Pironeau Robens). All parties refused medical attention at this time. Sgt. Jean-Marie arrived on scene in order to assist. ***see pg 2***
