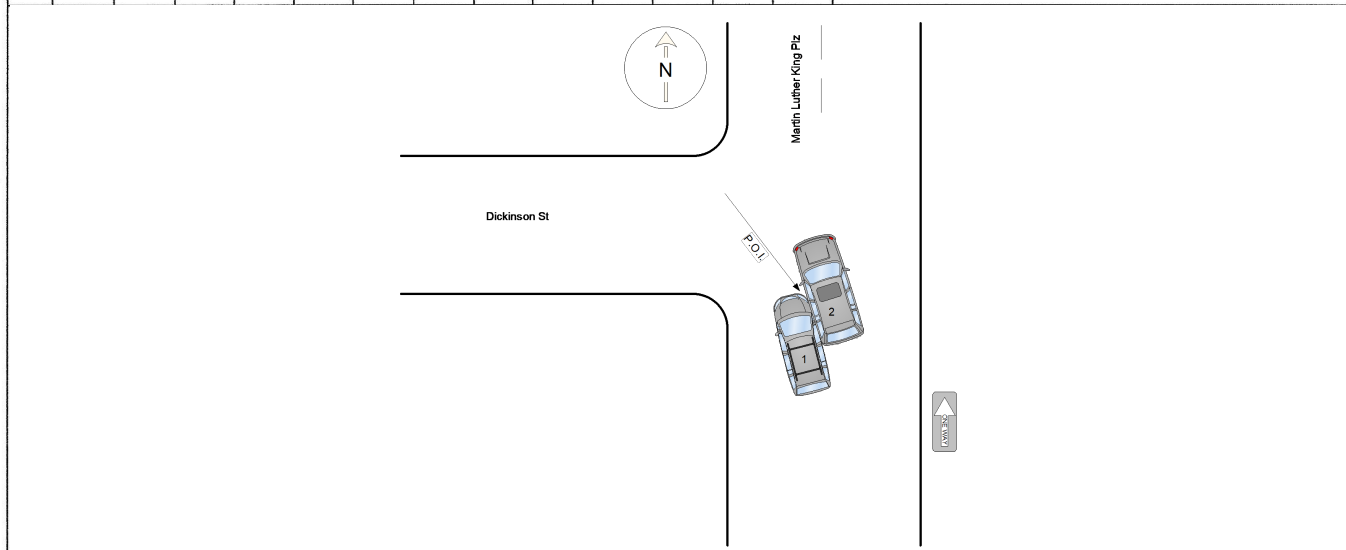

145. Crash Description/Narrative

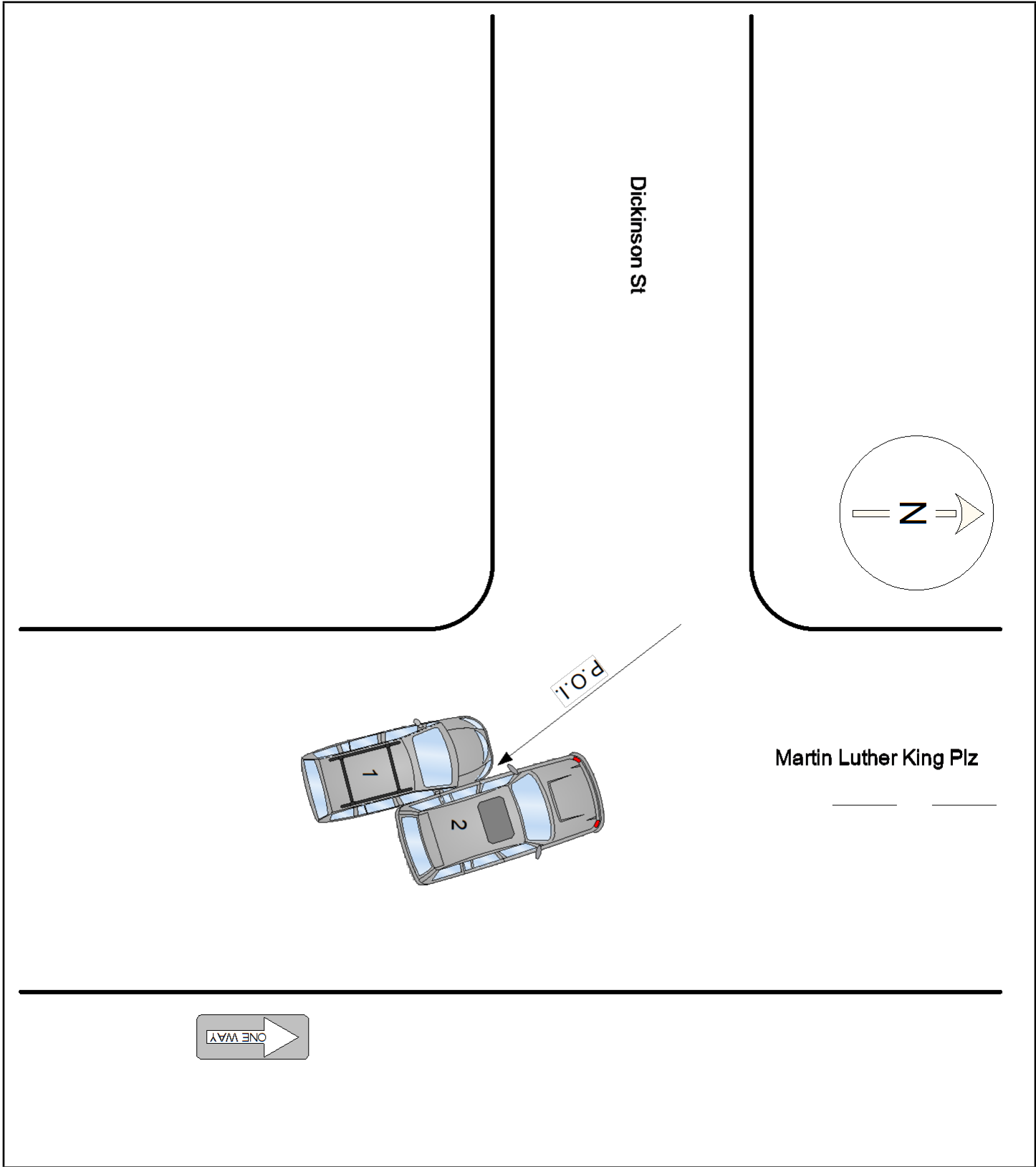
Driver of vehicle #1 states he was driving north on Martin Luther King Plaza while vehicle #2 was driving to his right side. As he approached the intersection of Dickinson St, driver of vehicle #2 made a left turn striking the front passenger side of his vehicle.

Driver of vehicle #2 states as she drove north on Martin Luther King Plaza, the driver of vehicle #1 attempted to pass her on the left hand side as she made the left turn onto Dickinson St, and struck the driver side of her vehicle.
