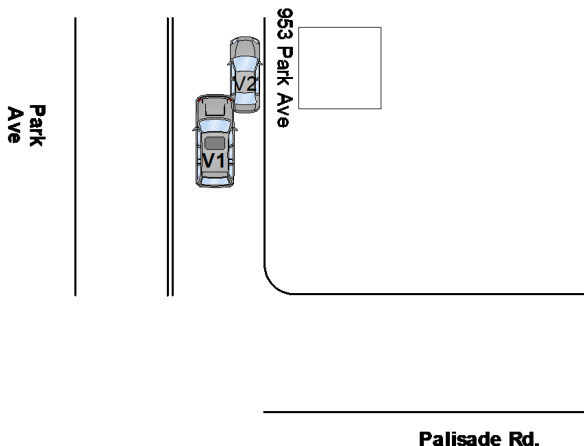

145. Crash Description/Narrative

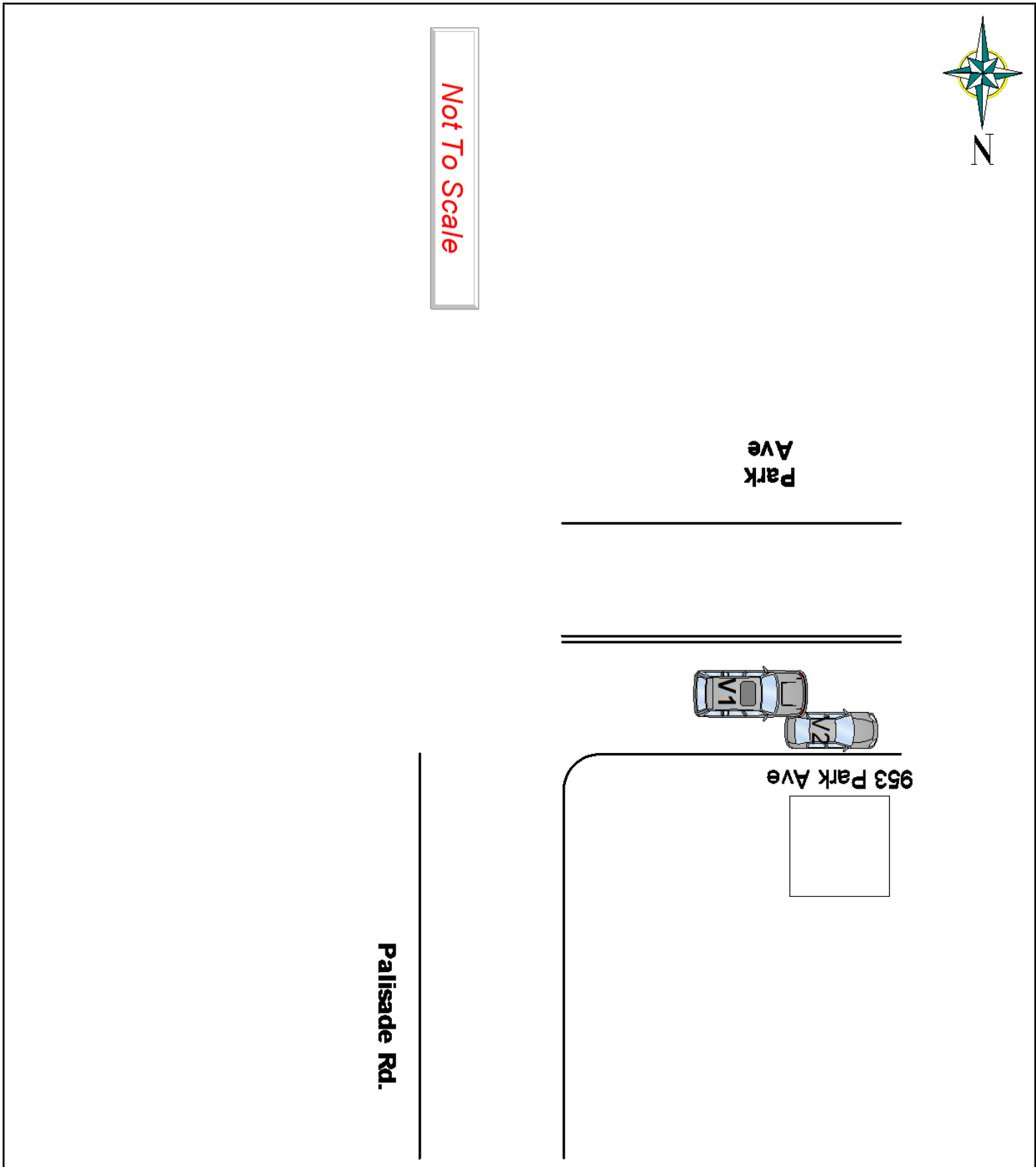
Z2 states he was inside of his home (853 Park Ave) when he heard a loud bang. He exited the home and was advised by a neighbor that an Acura MDX had struck his vehicle and fled west on Park Ave. A neighbor canvassed the area and discovered the suspect vehicle abandoned in front of 969 Coolidge Rd.

I responded to 969 Coolidge Rd and met with PO I. Kiniery, who was standing by with the suspect vehicle. An NCIC check of the suspect vehicle's registration revealed that the registered owner resided a short distance away in neighboring Union Township. Dispatch contacted the Union Police Department and requested that they respond to the registered owners address. The vehicle had heavy damage to the front passenger side wheel area, consistent with the damage suffered to V2. V1 was also missing its front wheel. The vehicle was locked and the ignition was intact. I observed a partially consumed bottle of Baccardi on the front passenger side floorboard.

An NCIC check of the V1's registration revealed that Marquise Howard had received summonses as recent as 02/19/2020 while operating the vehicle. Based on our investigation and the totality of the circumstances, Howard was determined to be the operator of V1. He was mailed summonses for the following Title 39 offenses: 39:4-96 (reckless driving, 39:4-129b (leaving the scene), 39:4-130 (failure to report), 39:4-56.5a (abandonment of MV), 39:3-40 (driving while suspended), 39:4-51b (possession of open container of alcohol in motor vehicle), and 39:6b-2 (Uninsured). See incident report under this case number for details regarding the on scene investigation. BWR.
