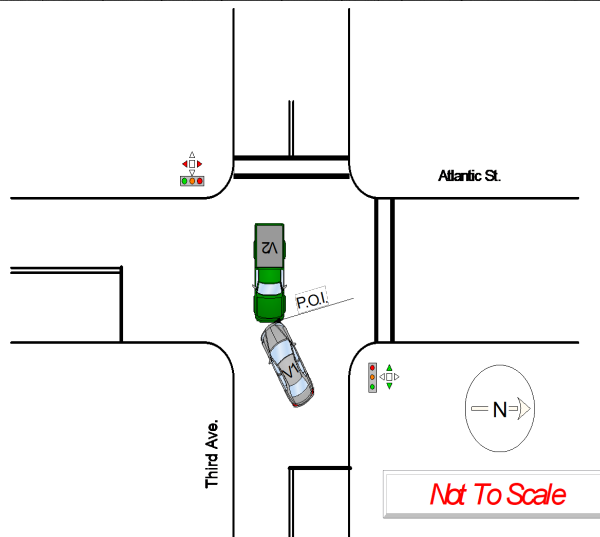

Veh. 1 then fled the scene heading South on Atlantic St. Veh. 1 then returned to the scene and began to flee East onto Third Ave. and turned North onto a side street.

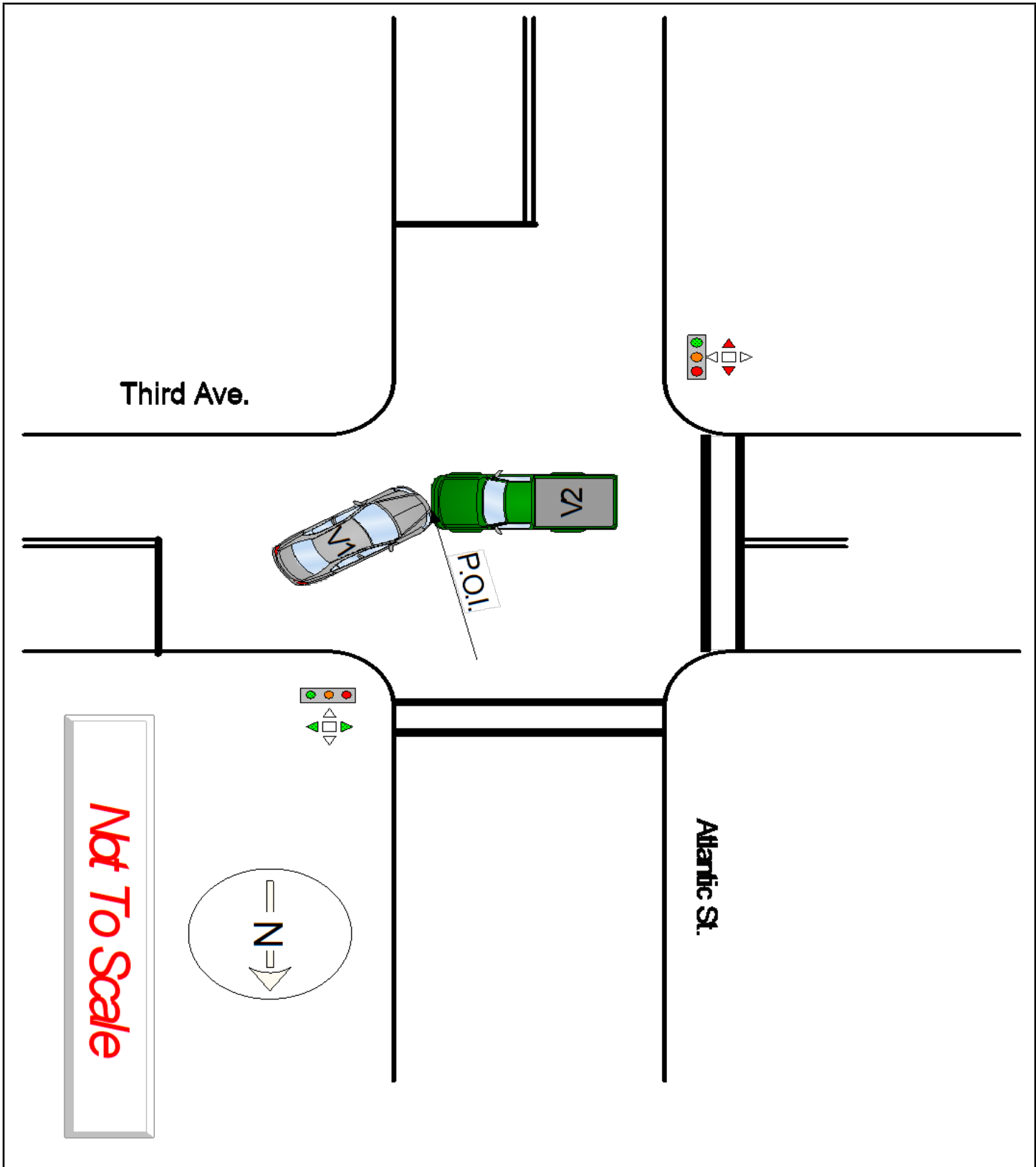
A search of the area for Veh. 1 proved negative.
