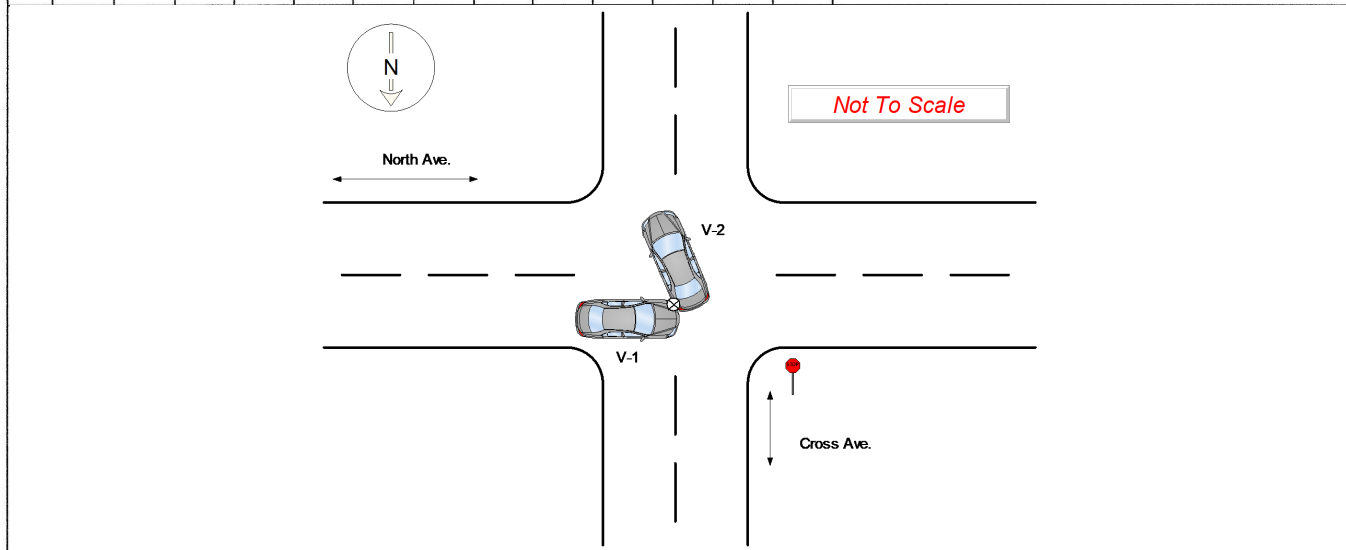

145. Crash Description/Narrative

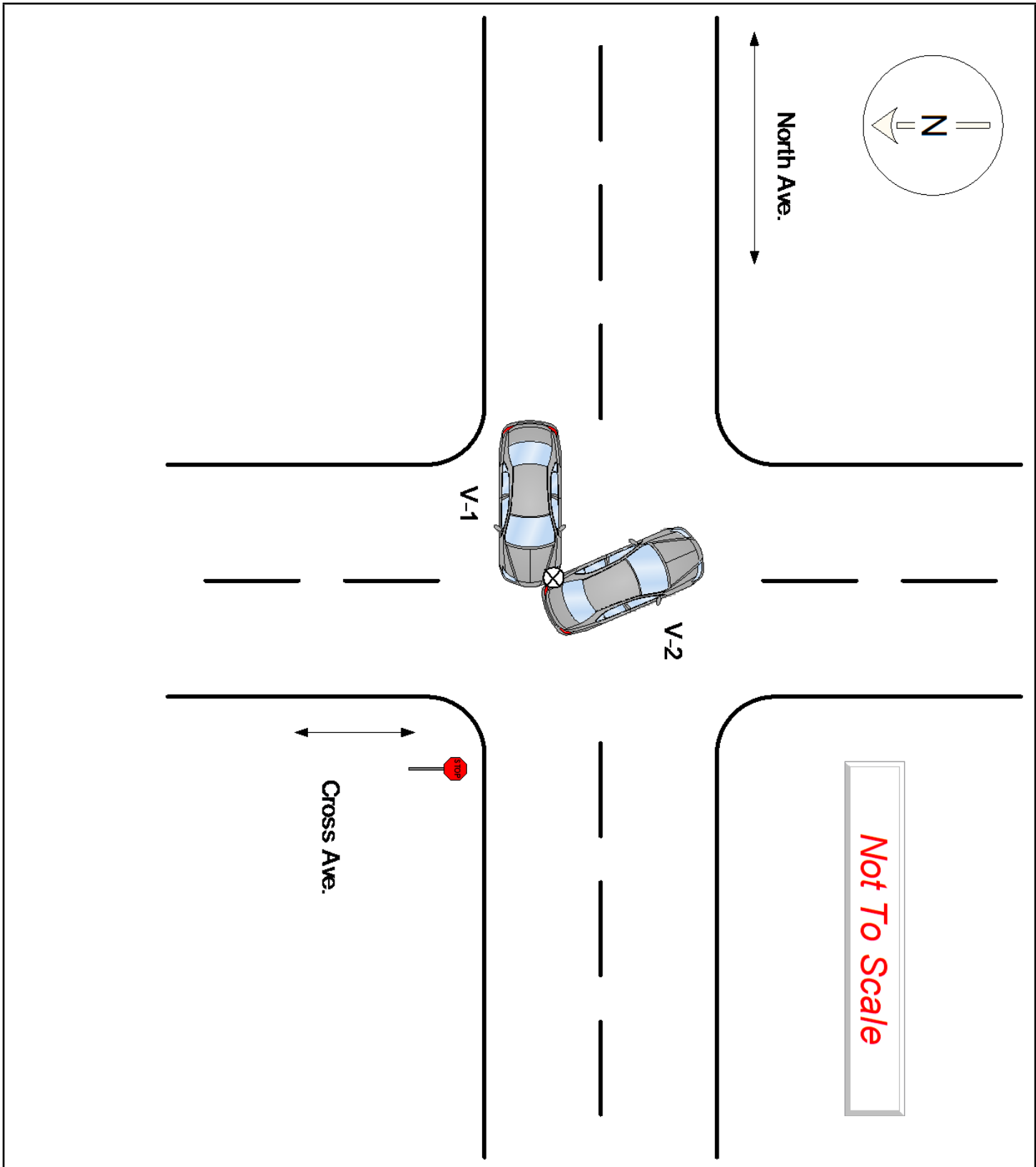
Driver 1 states while traveling West on North Ave. while approaching the intersection of North Ave. /
Cross Ave. Driver 1 observed vehicle 2 suddenly making a left turn from Cross Ave onto North Ave.
This caused vehicle 1 to strike vehicle 2.

Driver 2 states while traveling south on Cross Ave. he stopped at the stop sign located at Cross Ave. /
North Ave. Driver 2 further stated when he observed it was clear to enter the intersection he proceed
to make a left turn onto North Ave. Driver 2 further states vehicle 2 was then struck by vehicle 1.
