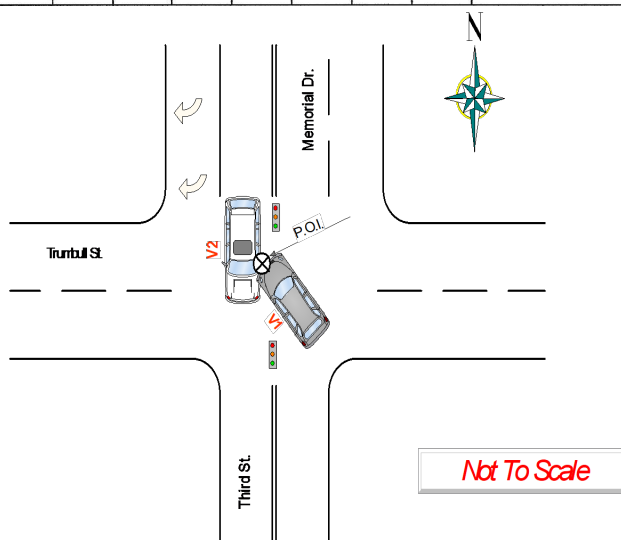

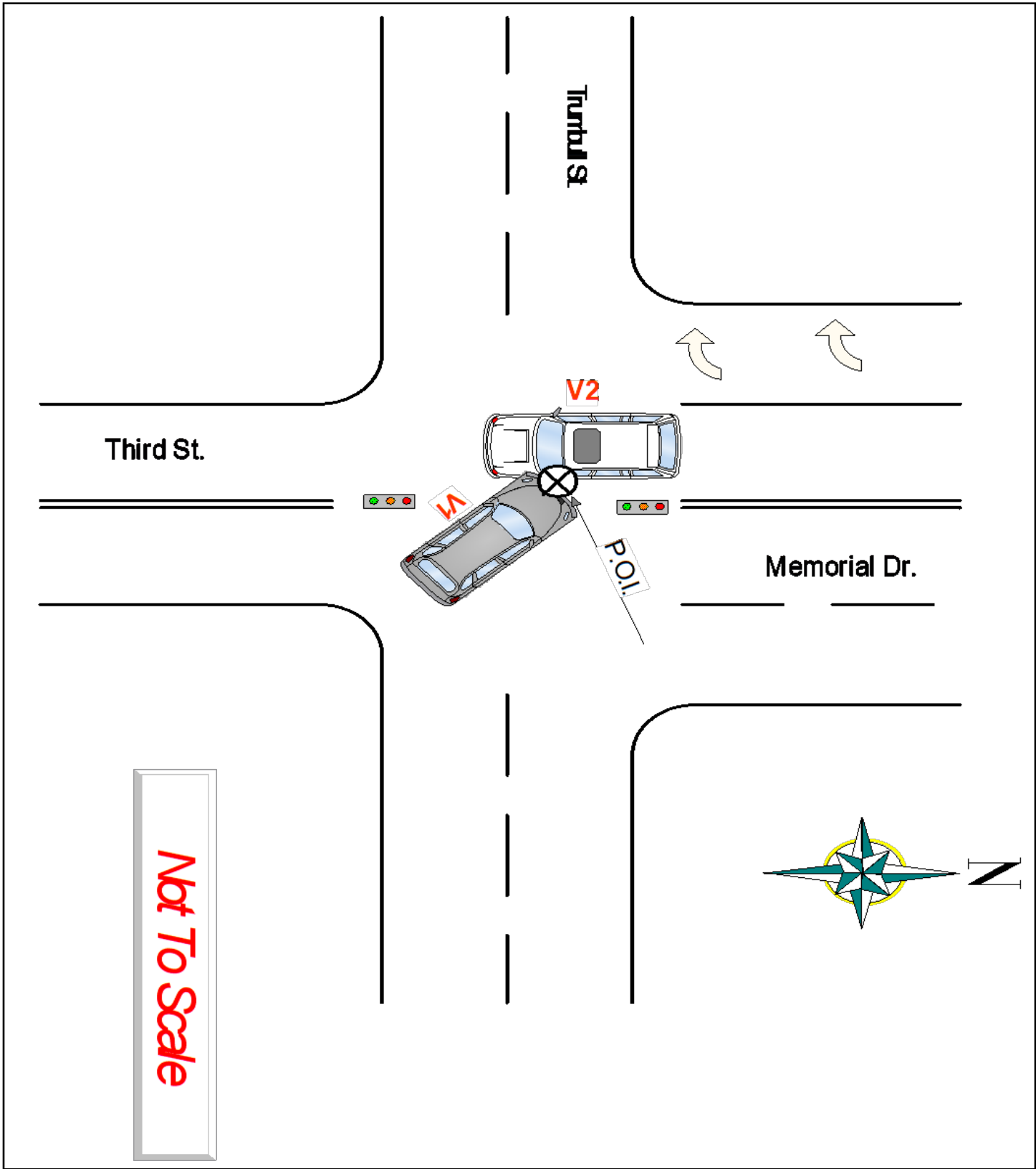
145. Crash Description/Narrative

Driver 1, Anthony Lopez-Evans, stated he was traveling North on Third St., and attempting to make a left onto Trumbull St. Same stated vehicle 2 was traveling at a high rate of speed and when he made the left hand turn he struck the driver side door on vehicle 2 causing moderate damage to his front bumper.

Driver 2, Bryan Uchoffen, stated he was traveling South on Memorial Drive and had the green light to continue straight to third Street. Same stated vehicle 1 attempted to make a left hand turn and struck his driver side door causing moderate damage to his driver side door.
