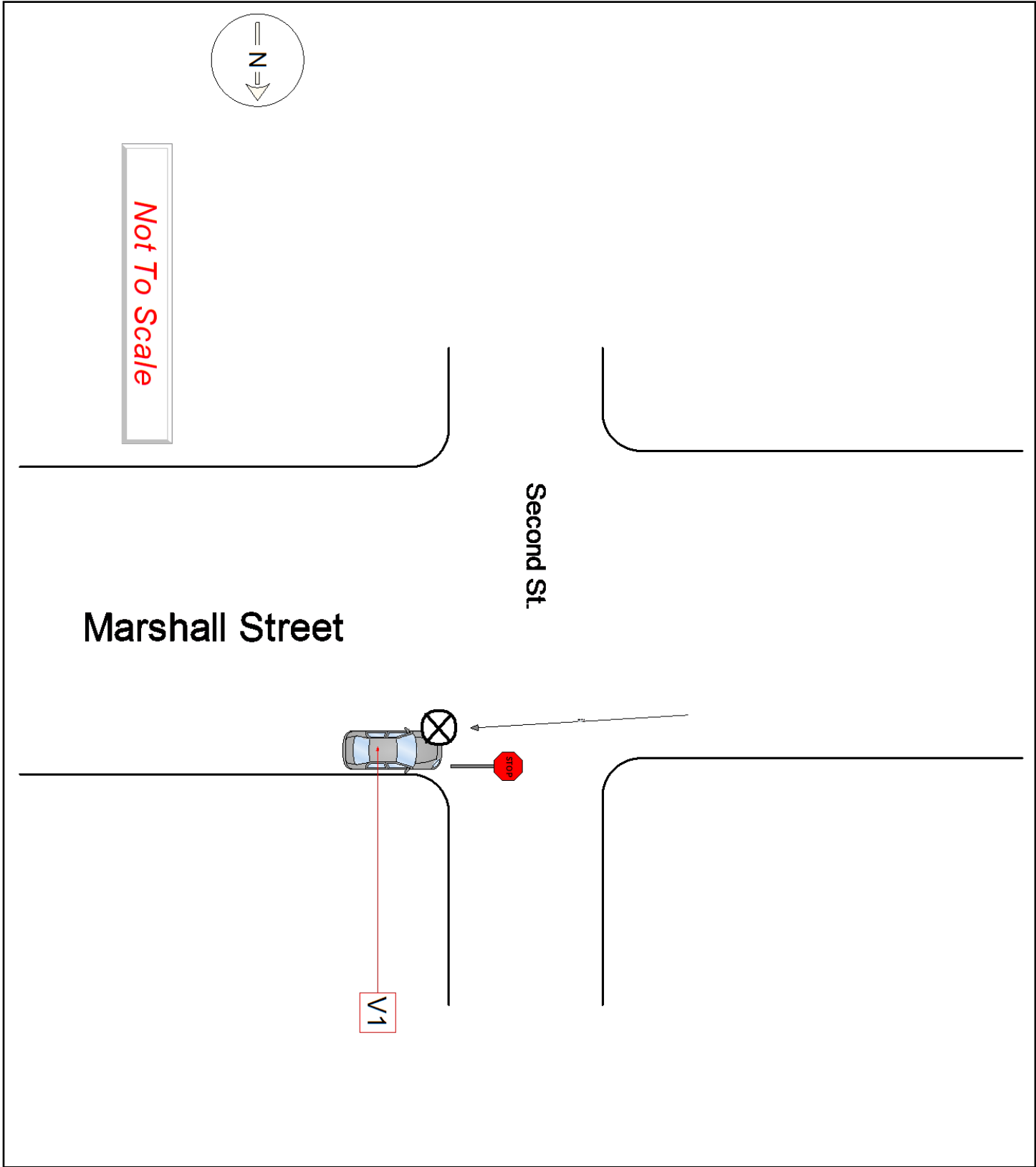
When he was done and returned home he parked the vehicle on South Second and Marshall Street at this time is when he noticed the vehicle had damage to the front drivers side.
