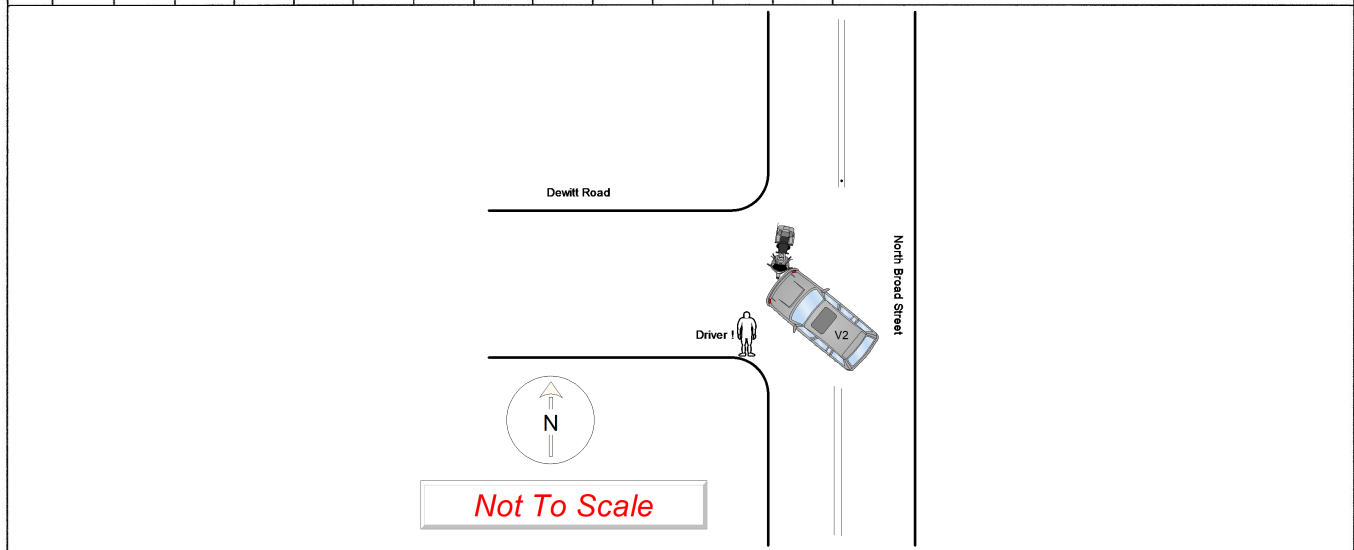

145. Crash Description/Narrative

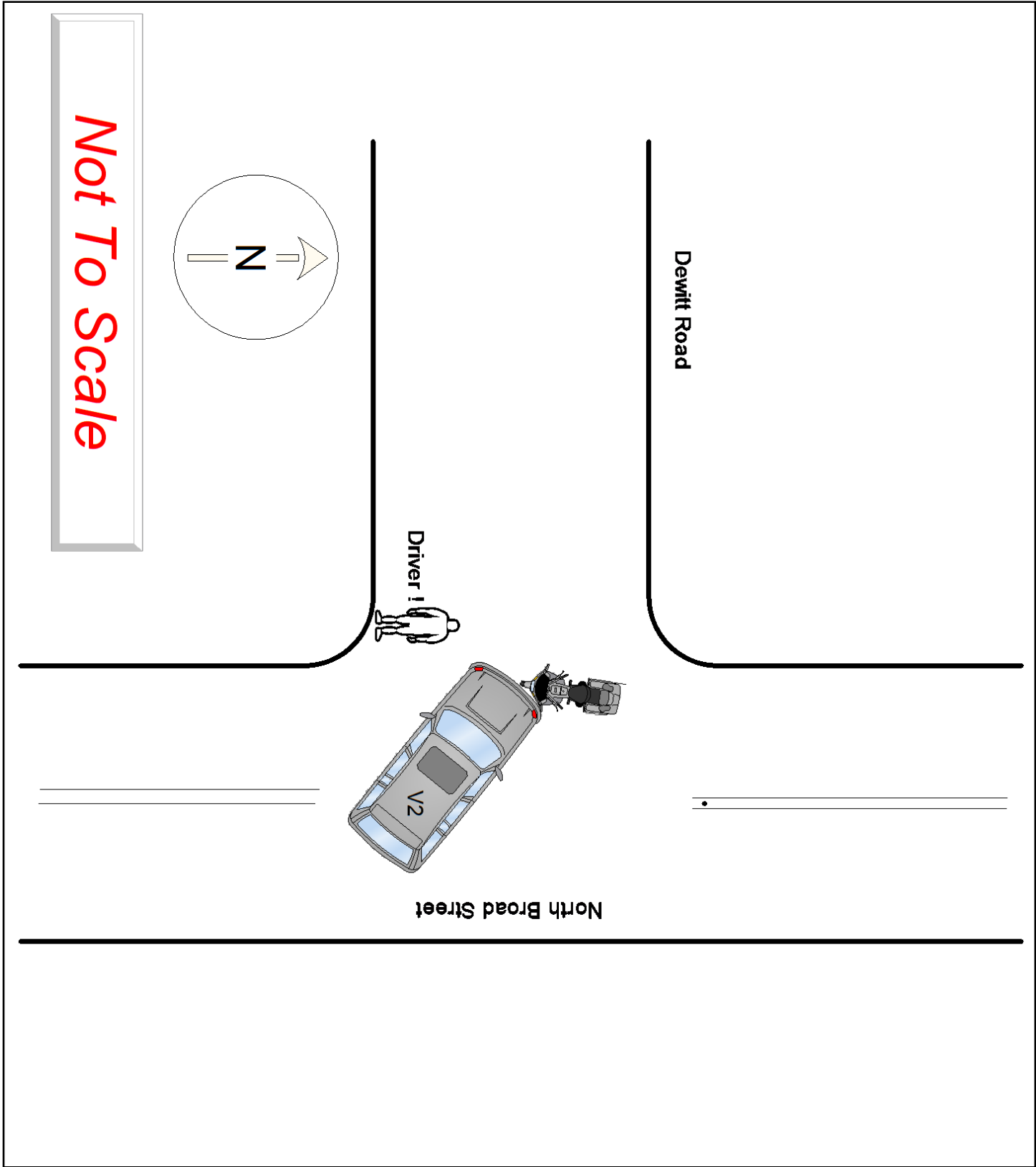
Driver 1 states he was driving south on North Broad Street approaching Dewitt Road when vehicle 2
