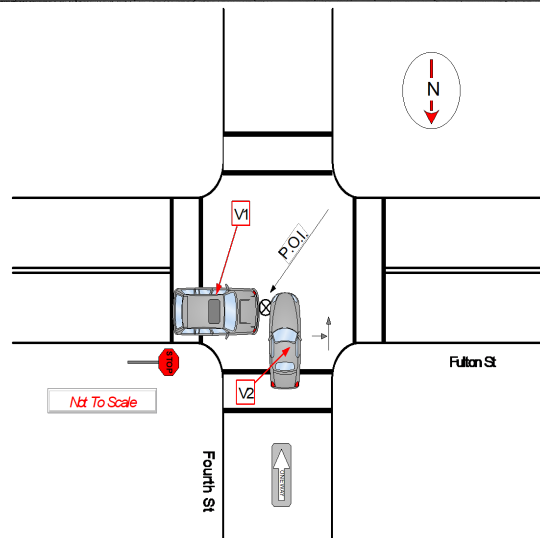

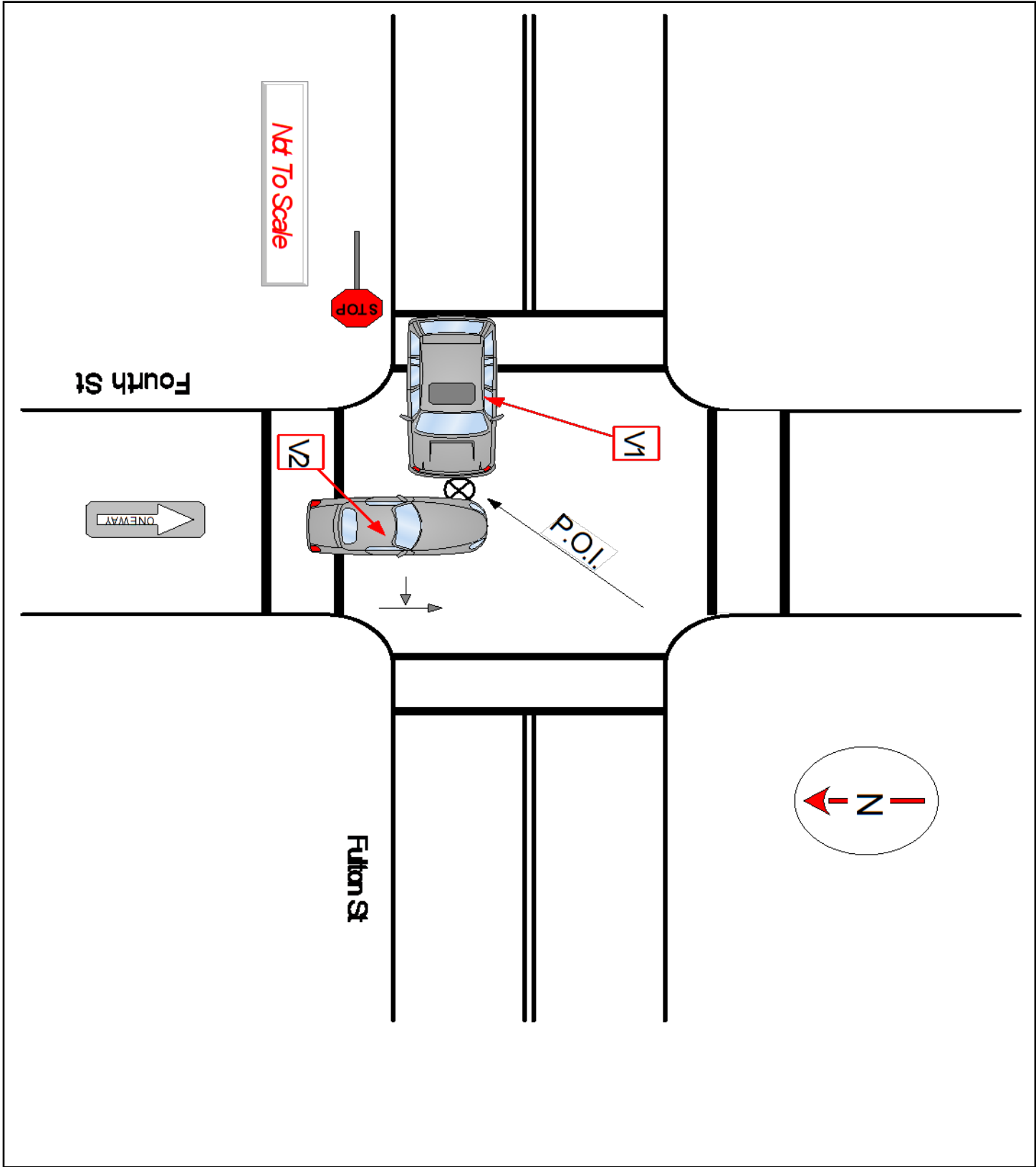
145. Crash Description/Narrative

D1 stated he was traveling westbound on Fulton Street as he approached the intersection with Fourth Street. D1 stated that he came to a complete stop and observed D2 stop her vehicle as she approached the intersection Southbound on Fourth Street. D1 stated that D2 began to slowly move forward as he began to drive through the intersection and he struck V2 on the front passenger side. D1 had the Stop sign.

D2 stated that she was traveling southbound on Fourth Street and slowed down as a precaution as she approached the intersection at Fulton Street. D2 stated that she never came to a complete stop and did not signal D1 to proceed. D2 stated that as she proceeded through the intersection, so did D1 and struck her. D2 did not have a signal present. No injuries reported. BWR.
