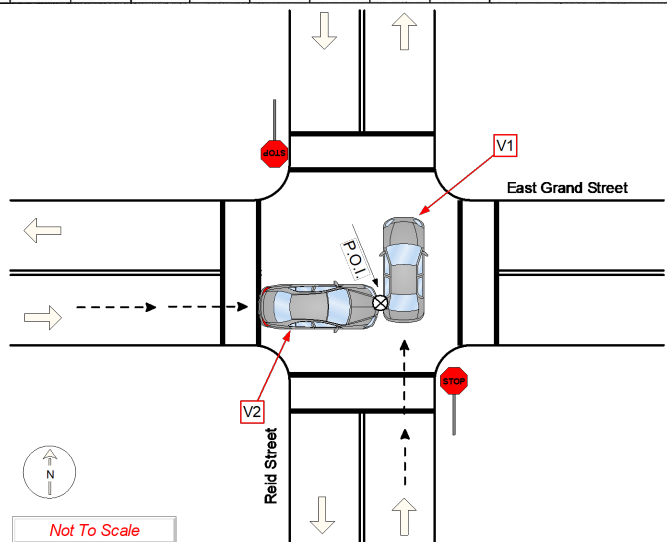

145. Crash Description/Narrative

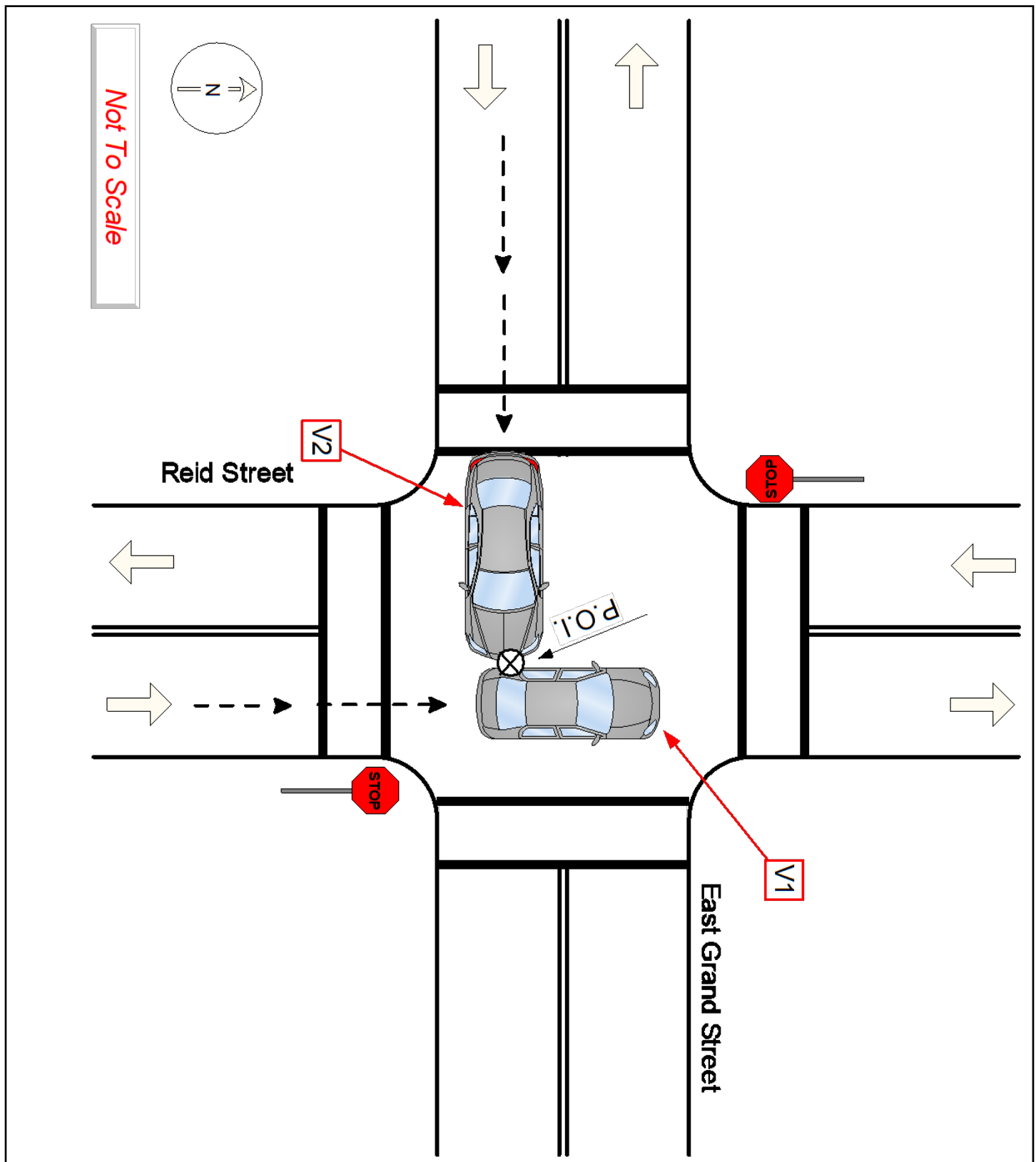
Driver of Vehicle 1 stated that while traveling Northbound on Reid Street, he collided with vehicle 2. Driver 1 stated that he stopped at the stop sign, looked both ways and proceeded. Driver 1 stated that halfway through the intersection of Reid Street and East Grand Street, his vehicle was struck by vehicle 2. Driver 1 stated that he observed vehicle 2 traveling at a high rate of speed and did not attempt to stop prior to collision. Vehicle 1 sustained moderate damages to the driver side rear quarter panel and wheel. Driver 1 and passenger 1 refused medical attention at this time.

Driver of Vehicle 2 stated that while traveling Eastbound on East Grand Street, he collided with vehicle 1. Driver 2 stated that vehicle 1 disregarded the stop sign at the intersection. Vehicle 2 sustained moderate damages to the front end. Driver 2 and passenger 2 refused medical attention at this time.

There are multiple cameras located at The 4J grocery Store (930 East Grand Street) that might have captured the incident. Parties were advised accordingly. BWR.
