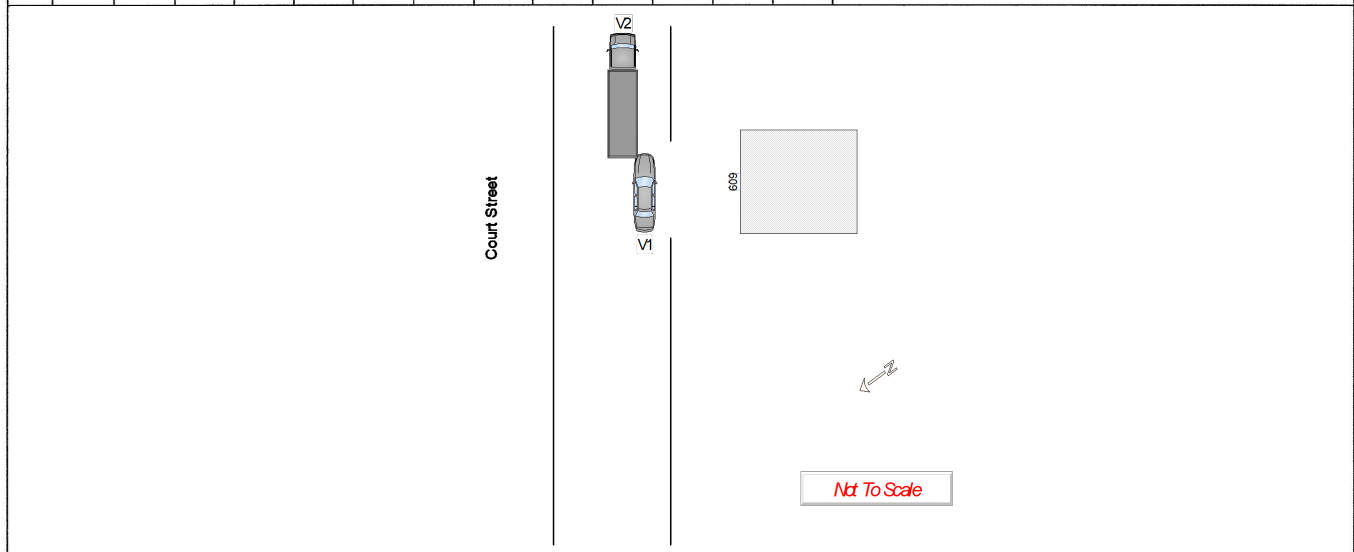

Operator of vehicle 1 states she was stopped when the operator of vehicle 2 backed into the vehicle.

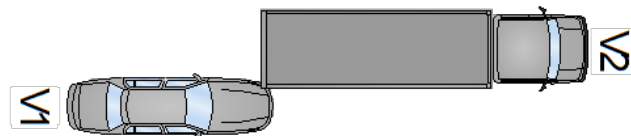
