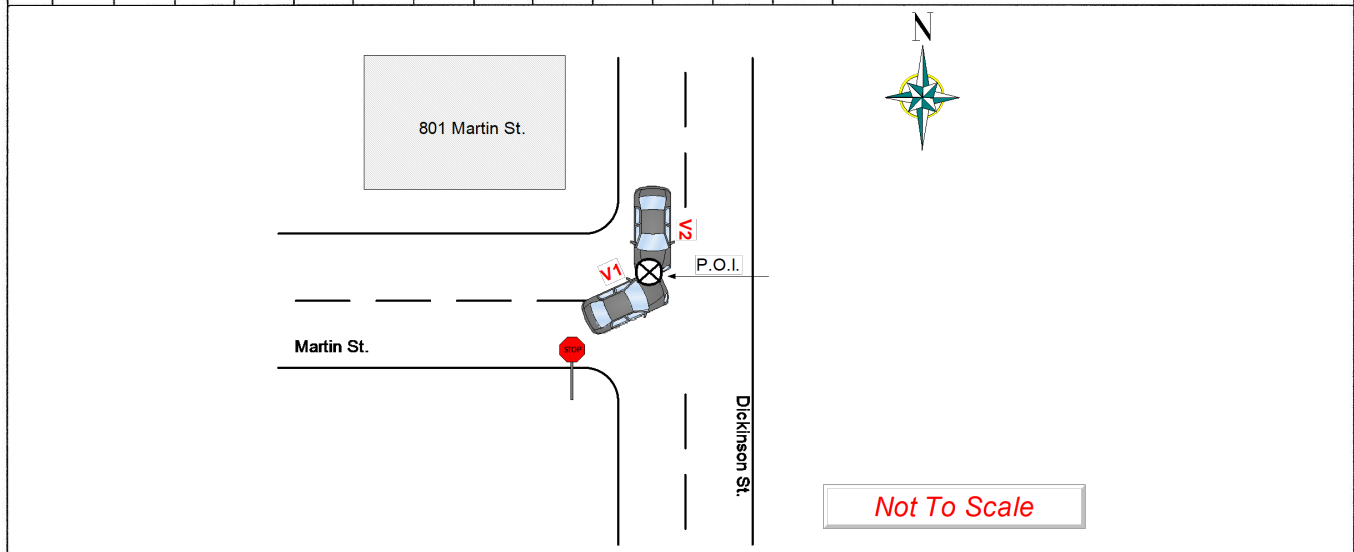

145. Crash Description/Narrative

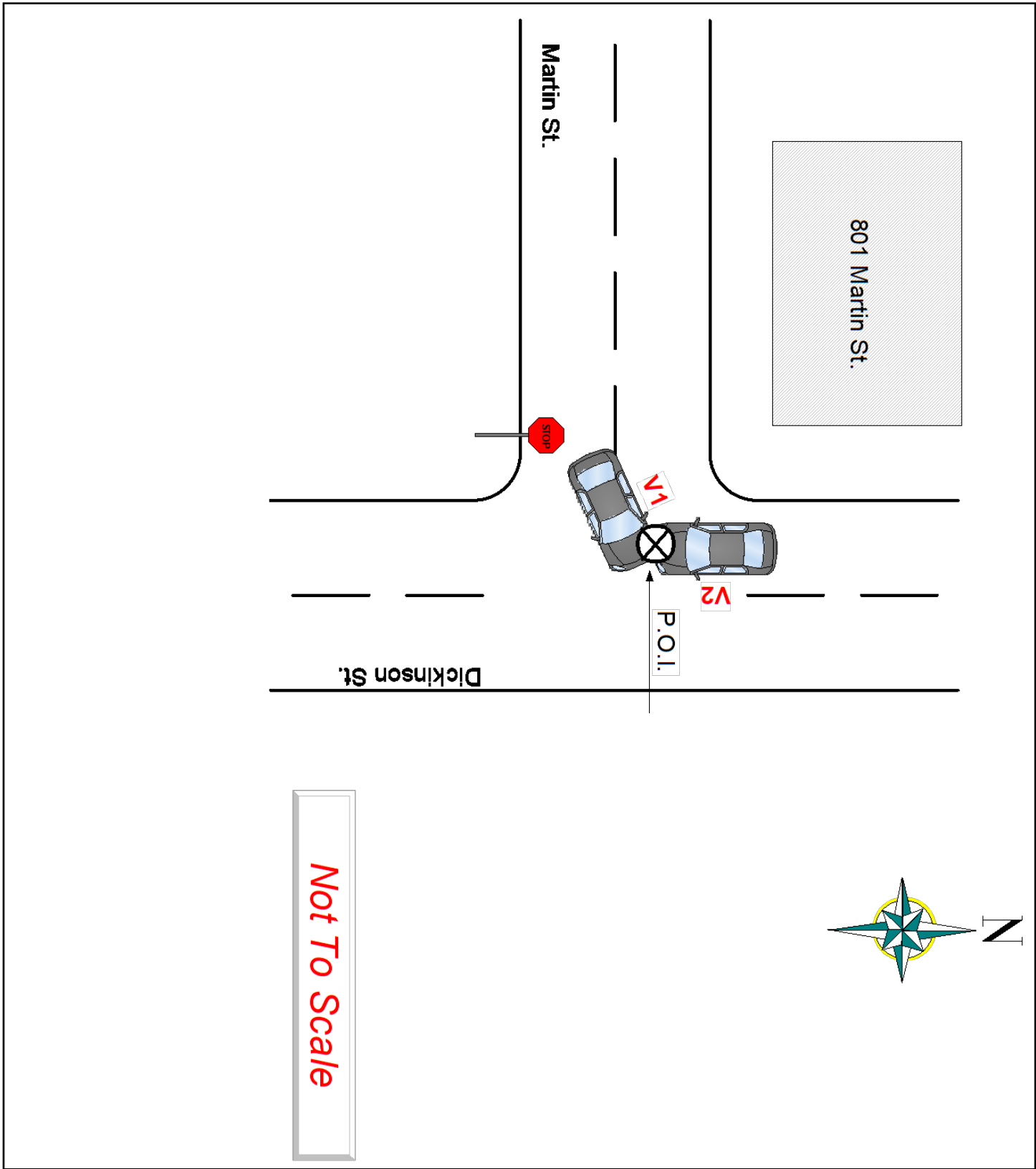
Driver 2, Margarita Ramirez, stated she was traveling south on Dickinson St., when a gray Acura sedan made a left from Martin St., onto Dickinson St. Same stated the driver pulled in front of her and could not stop the vehicle in time and collided with vehicle 1's front bumper causing minor damage to her vehicle. Ms. Ramirez stated the driver of vehicle 1, a Hispanic female in her mid-twenties, stopped and said the accident was her fault and fled the scene prior to police arrival. Same stated she took a photo of the vehicle's plate prior to the vehicle fleeing the scene, NJ H66MFD.

Driver 1 was not present to give her statement. Multiple summons was issued and mailed to registered owner.

A witness, George Cueva, stated he observed the accident and saw vehicle 1 run through the stop sign prior to the collision
