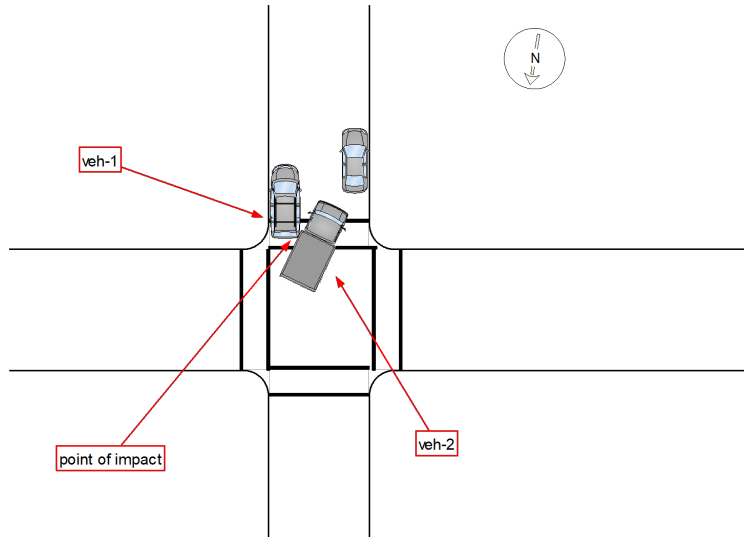

145. Crash Description/Narrative

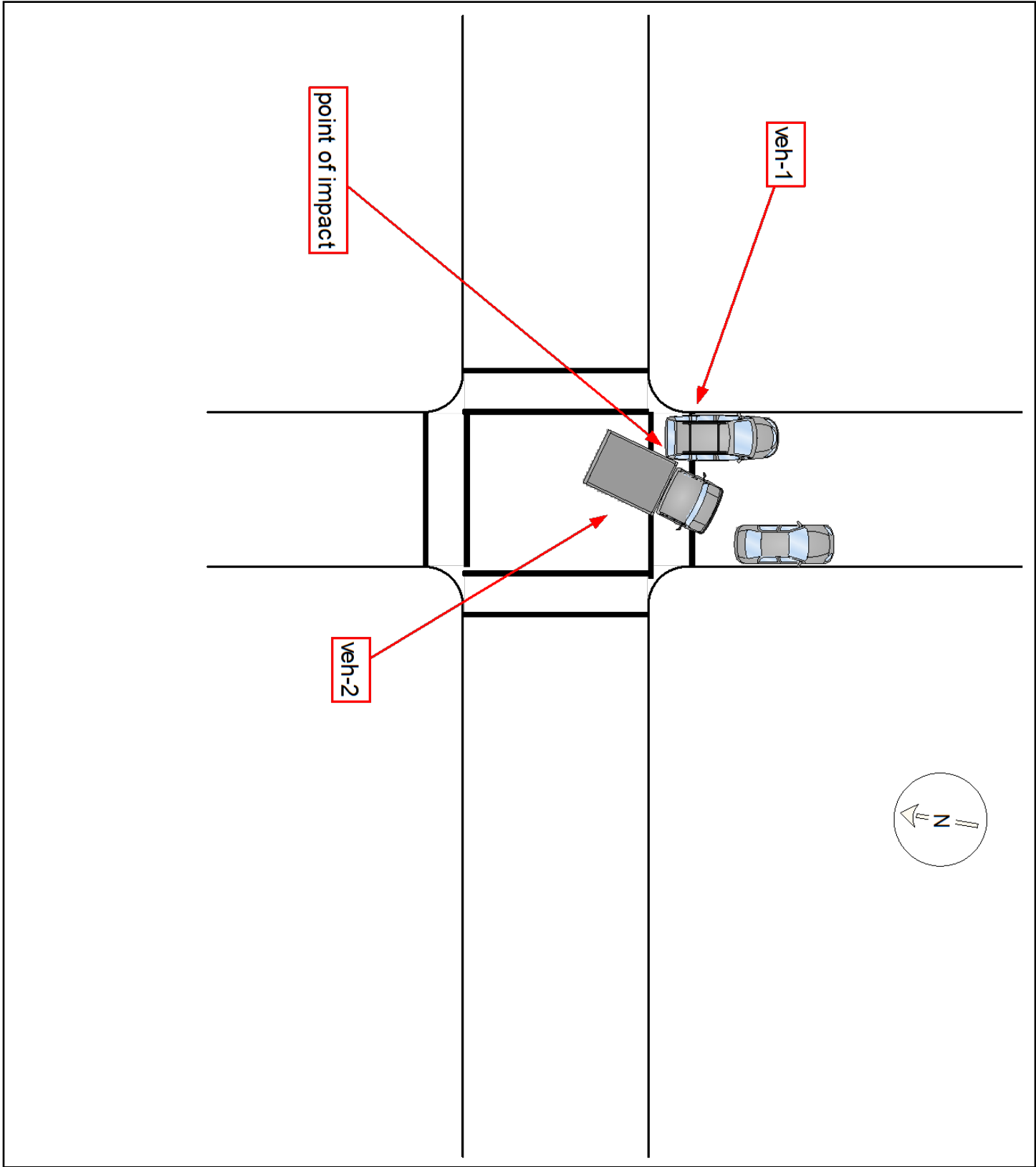
Zhizhingo-Santand, Sandra (veh-1) statd she was parked t the corner when her vehicle was struck by veh-2.
