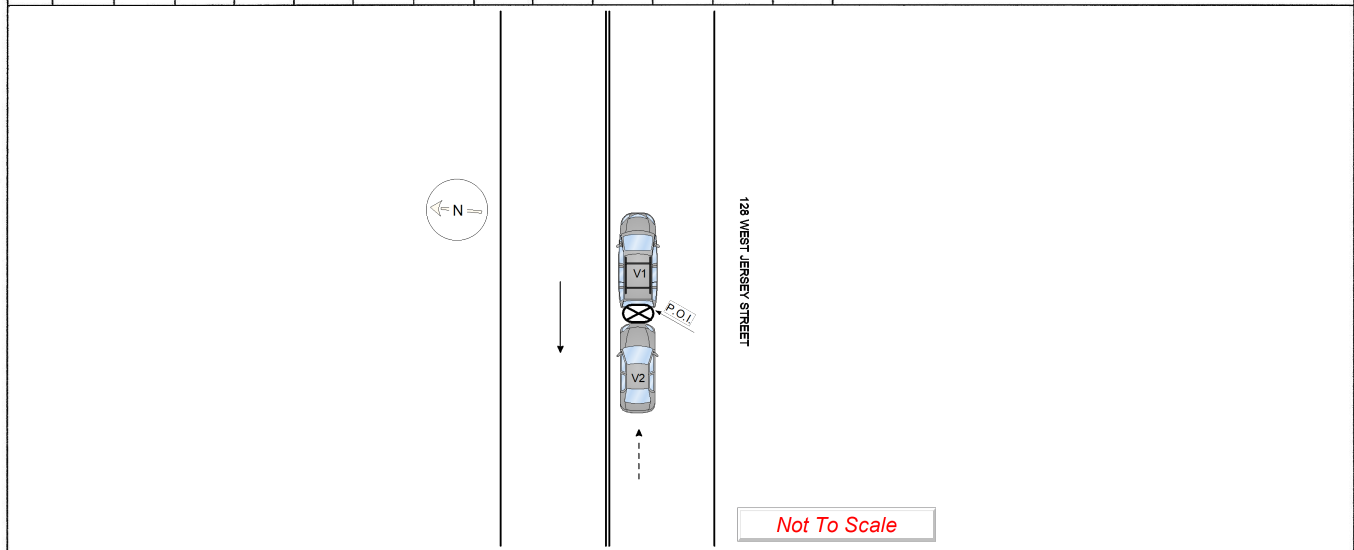

145. Crash Description/Narrative

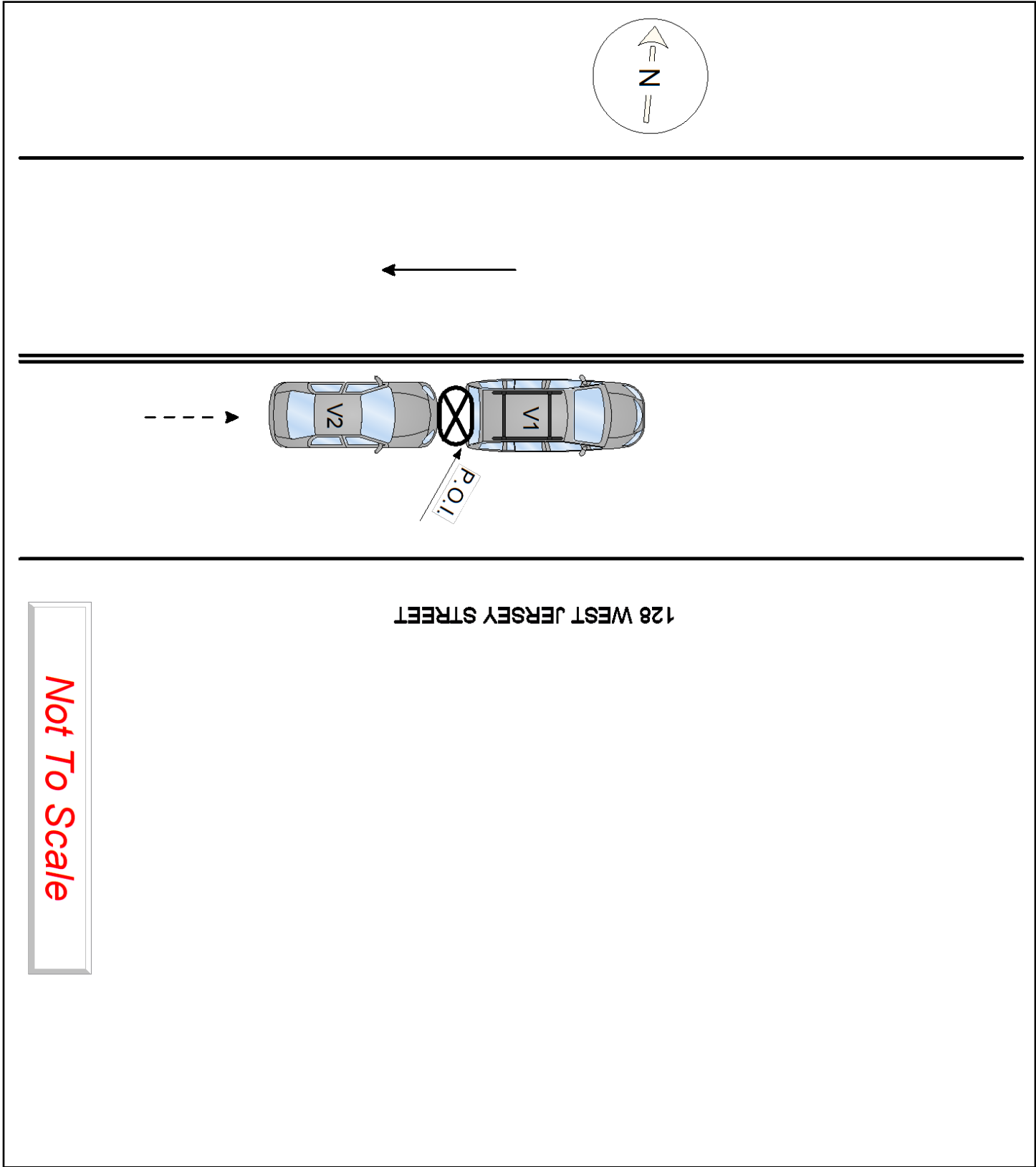
Driver of Veh#1 states he was stopped in traffic in front of 128 West Jersey Street (east) when he was suddenly rear ended by Veh#2.
