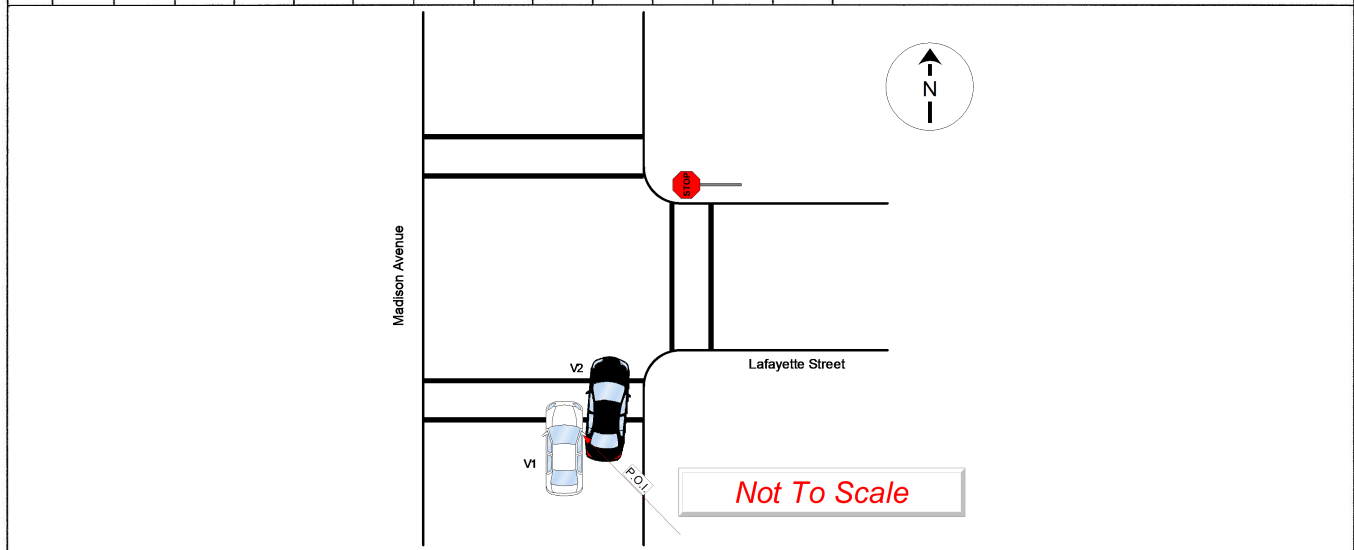

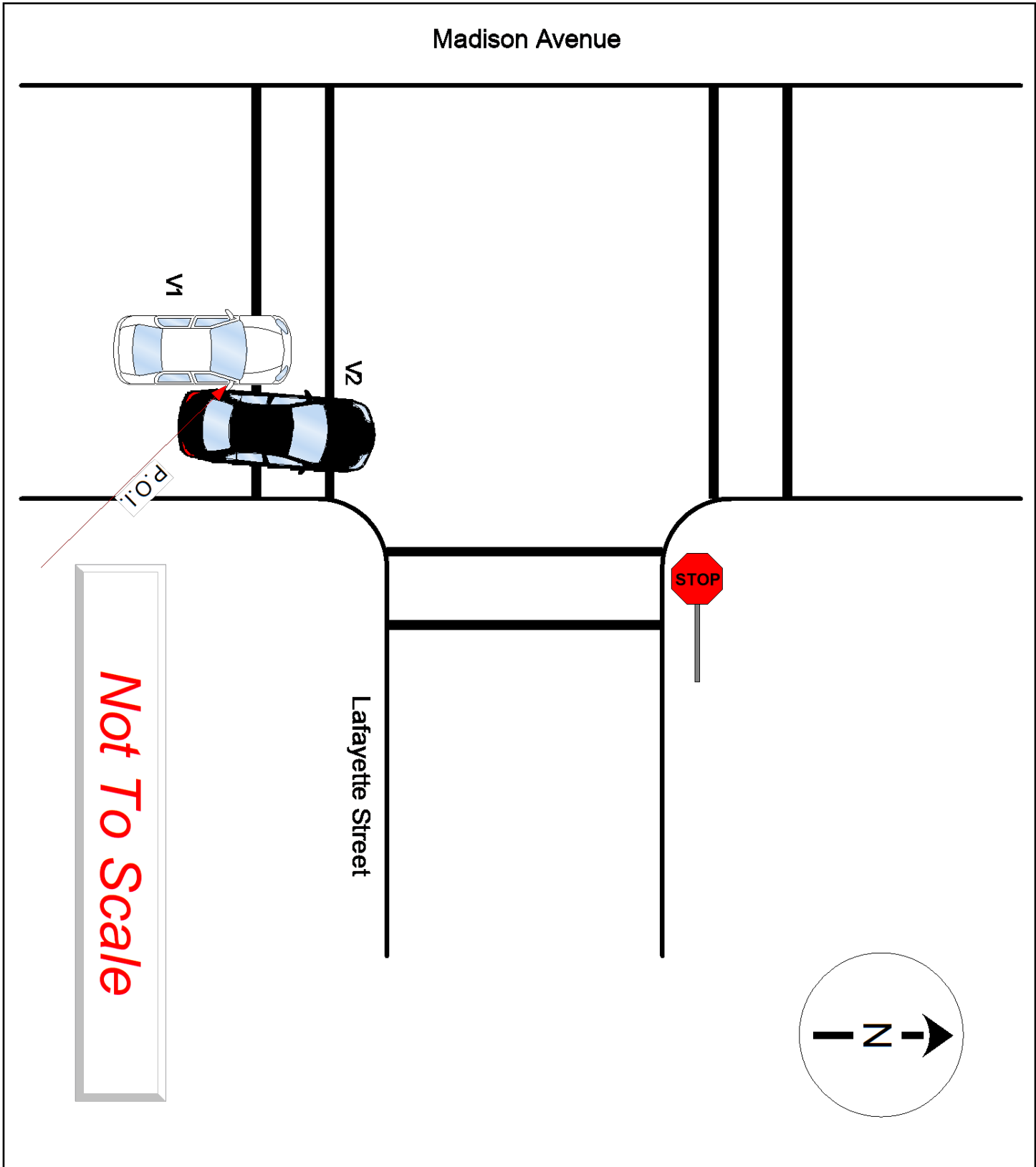


145. Crash Description/Narrative

Driver of V1 stated that while traveling north on Madison Avenue approaching Lafayette Street he began to overtake V2 which was slightly pulled over at that intersection. Upon doing so, the rear drivers side passenger of V2 abruptly opened the door which caused the collision. Driver of V2 (Network Transportation Driver) stated that she was attempting to make a right turn onto Lafayette Street from Madison Avenue when her (l yft) passenger yelled stop and opened the rear drivers side door without warning which caused the collision. Passenger of V2 stated that he wished to exit the vehicle and asked driver of V2 to pull over. Passenger of V2 then opened the rear drivers side door which caused the collision. V2 out of state insurance (Progressive Insurance) Policy #929019391. Damage observed to V1's passengers side view mirror and V2's rear drivers side door. BWR/eor.
