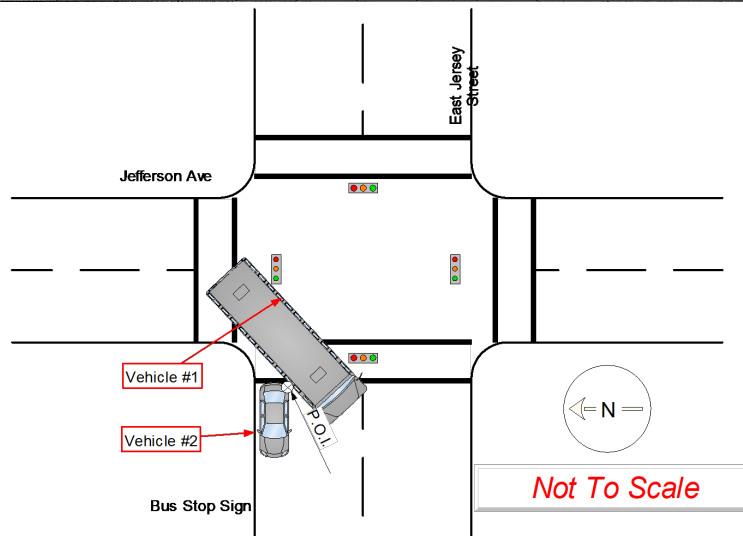

145. Crash Description/Narrative

Driver 1 - Stated he was traveling southbound on Jefferson Avenue while attempting to make a right hand turn onto East Jersey Street when he struck vehicle #2 who was parked at the bus stop area. Driver #1 stated that he wasn't able to complete the turn do to the vehicle being illegally parked.

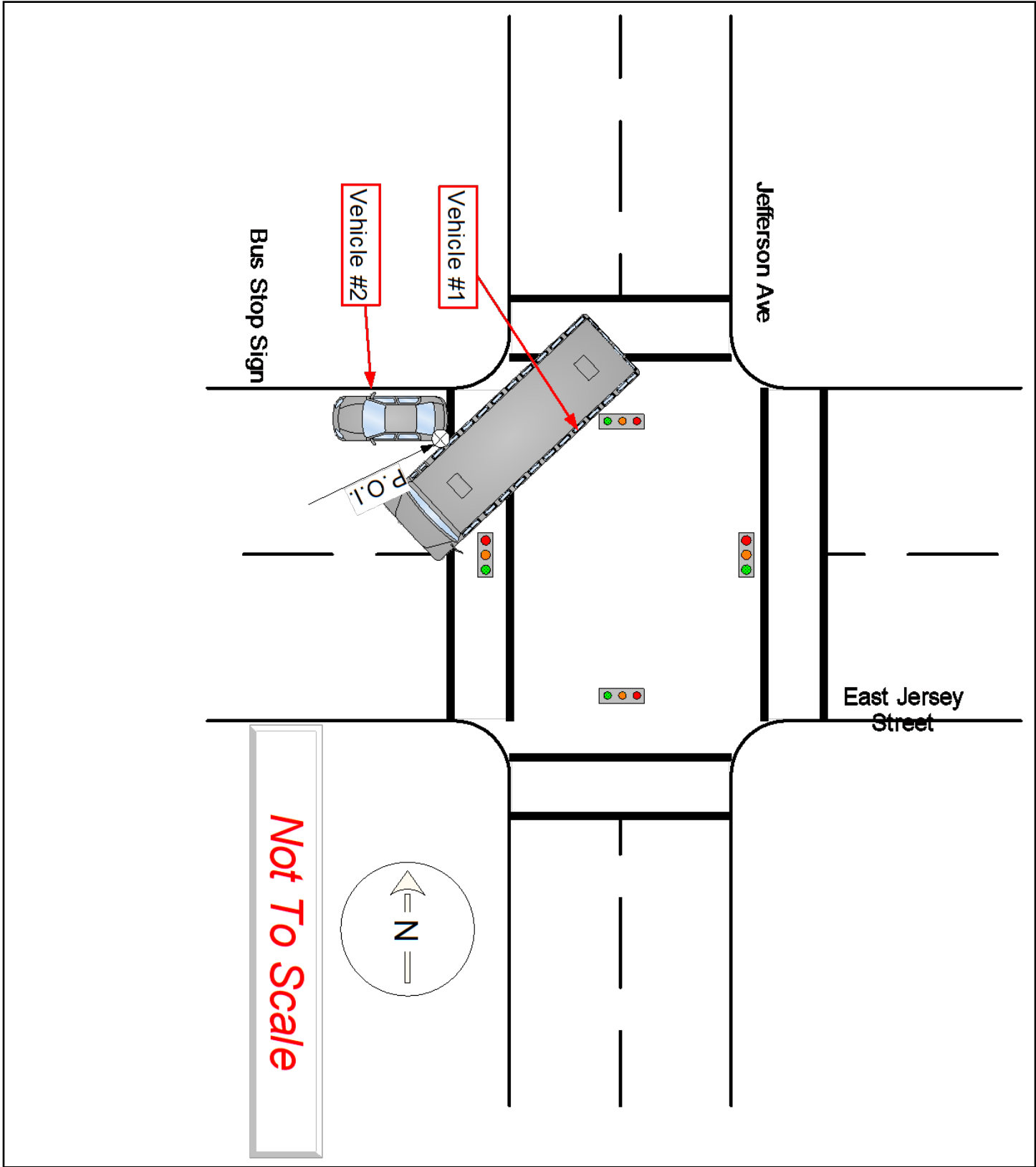
Driver 2 - Stated she was parked at the corner of East Jersey Street and Jefferson Avenue which is directly in front of 1148 East Jersey Street awaiting for a friend. Same stated when her friend entered the vehicle she was suddenly struck by vehicle #1 who was attempting to make a right hand turn from Jefferson onto East Jersey Street.

These Officers observed minor dents and scratches on both vehicles, it should also be noted that all parties refused medical attention and proceeded to their destination. Also on upon our arrival there were no passengers occupying the New Jersey Transit Bus
