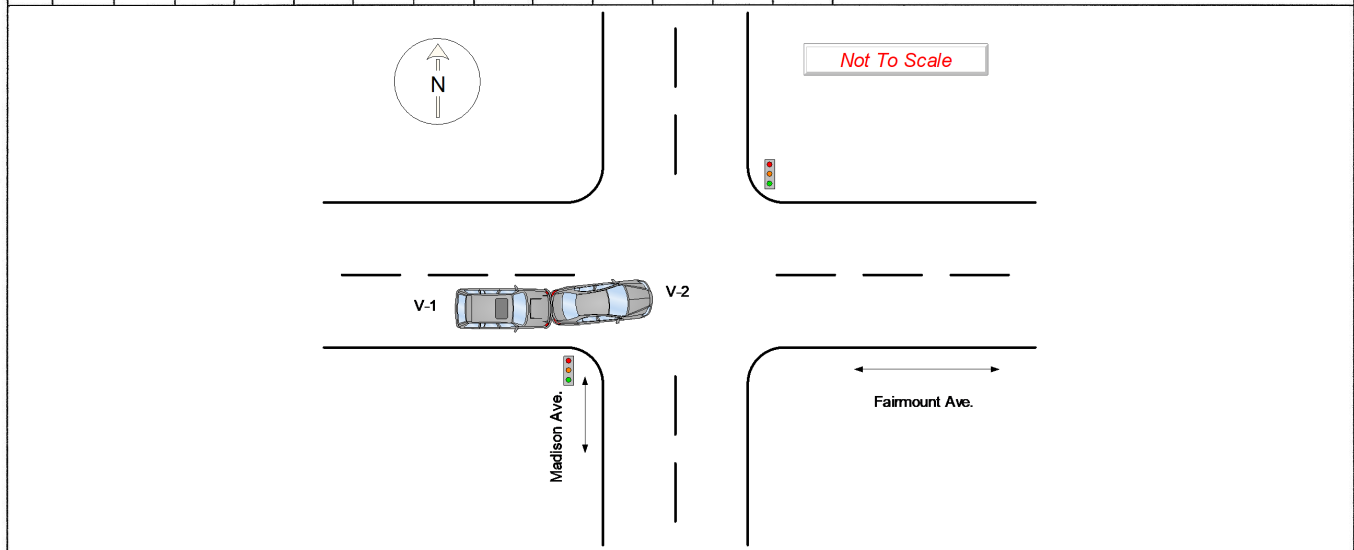

145. Crash Description/Narrative

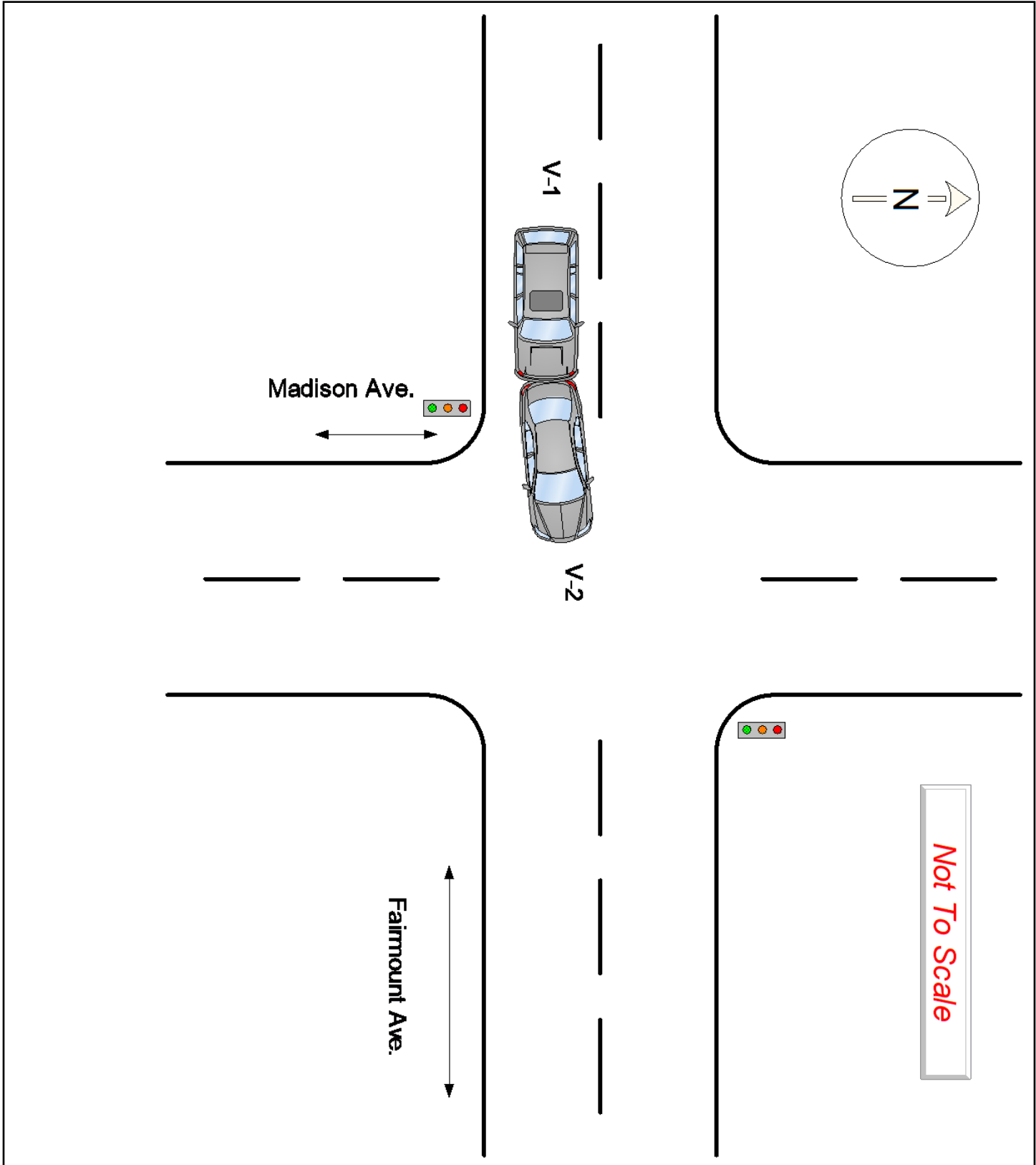
Driver 1 states while traveling east on Fairmont Ave., he stopped behind vehicle 2 at a red traffic light located at the intersection of Fairmont Ave / Madison Ave. Driver 1 further stated when the traffic light turned green, Vehicle 2 proceeded to travel east into the intersection. Driver 1 then states vehicle 2 then suddenly stopped in the intersection, driver 1 was unable to stop vehicle 1 in time causing vehicle 1 to strike vehicle 2.

Driver 2 states while traveling east on Fairmont Ave., he observed a green traffic light at the intersection of Fairmont Ave. / Madison Ave. Driver 2 proceeded to travel into the intersection with his left turn signal on to make a left turn onto Madison Ave. Driver 2 further stated he then stopped vehicle 2 to allow traffic from the west bound lane to clear so he could continue to make a left turn. Driver 2 then states, vehicle 2 was suddenly then struck by vehicle 1.
