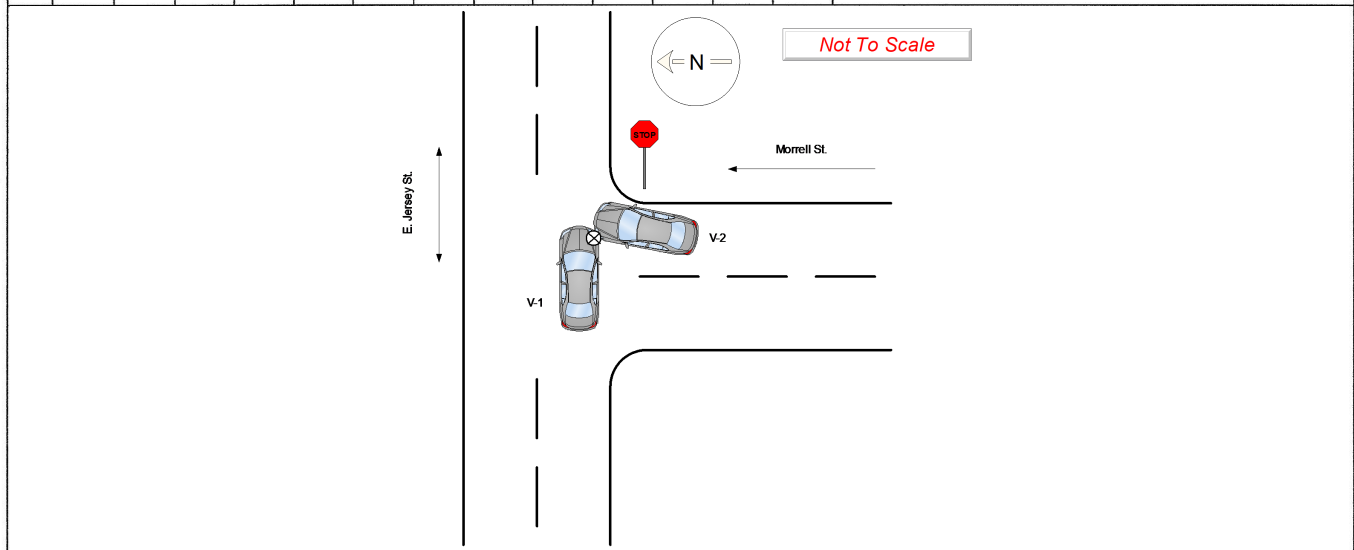

145. Crash Description/Narrative

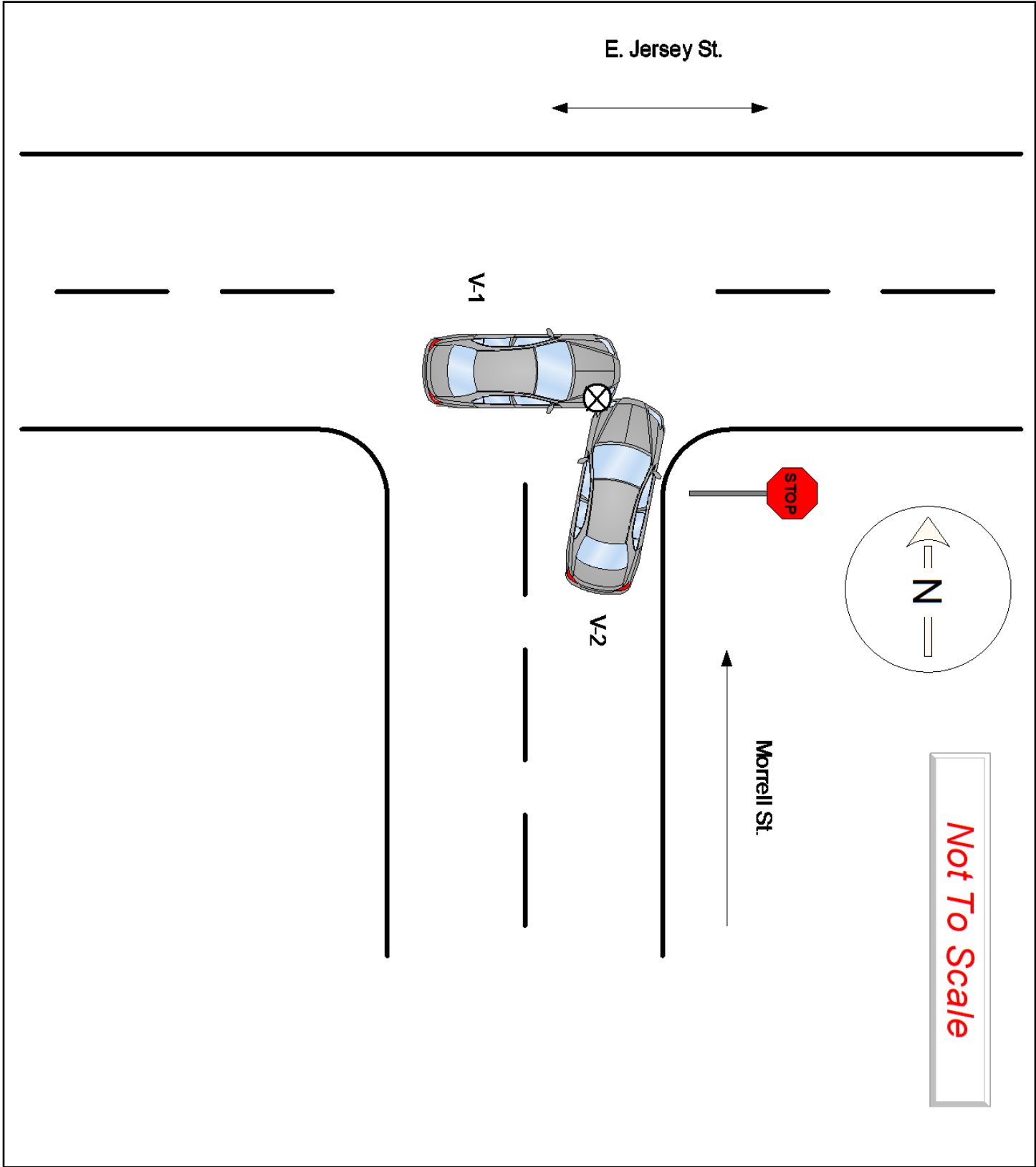
Driver 1 states while traveling east on E. Jersey St., he was approaching the intersection of E. Jersey St. / Morrell St. Driver 1 further states while traveling through the intersection, driver 1 observed vehicle 2 suddenly entered the intersection. Driver 1 then states he was unable to stop vehicle 1 in time, causing vehicle 2 to strike vehicle 1.

Driver 2 states while traveling north on Morrell St., he stopped at the stop sign located at the intersection of Morrell St. / E. Jersey St. Driver 2 further states when he observed the road was clear, he entered the intersection attempting to make a right turn. Driver 2 then observed vehicle 1 traveling east on E. Jersey St. at a high rate of speed, this caused vehicle 1 to strike vehicle 2.
