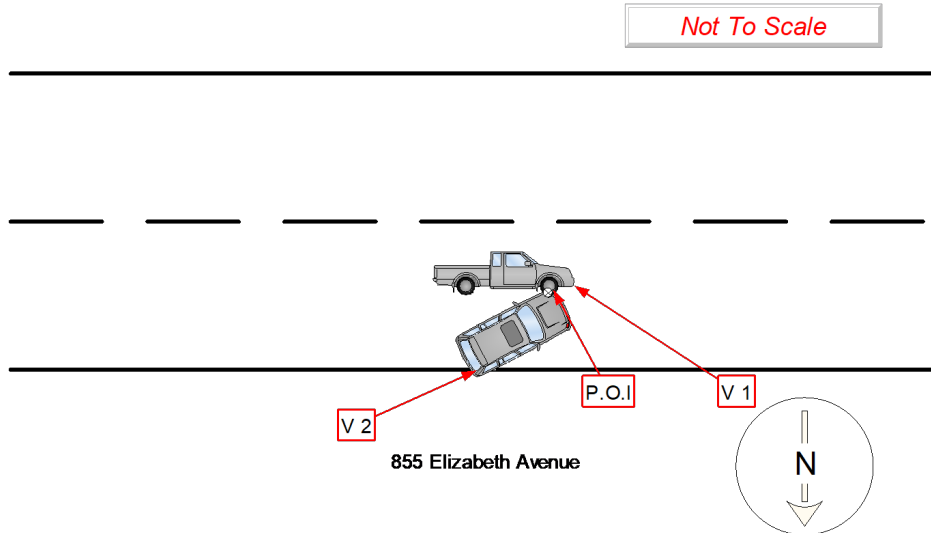

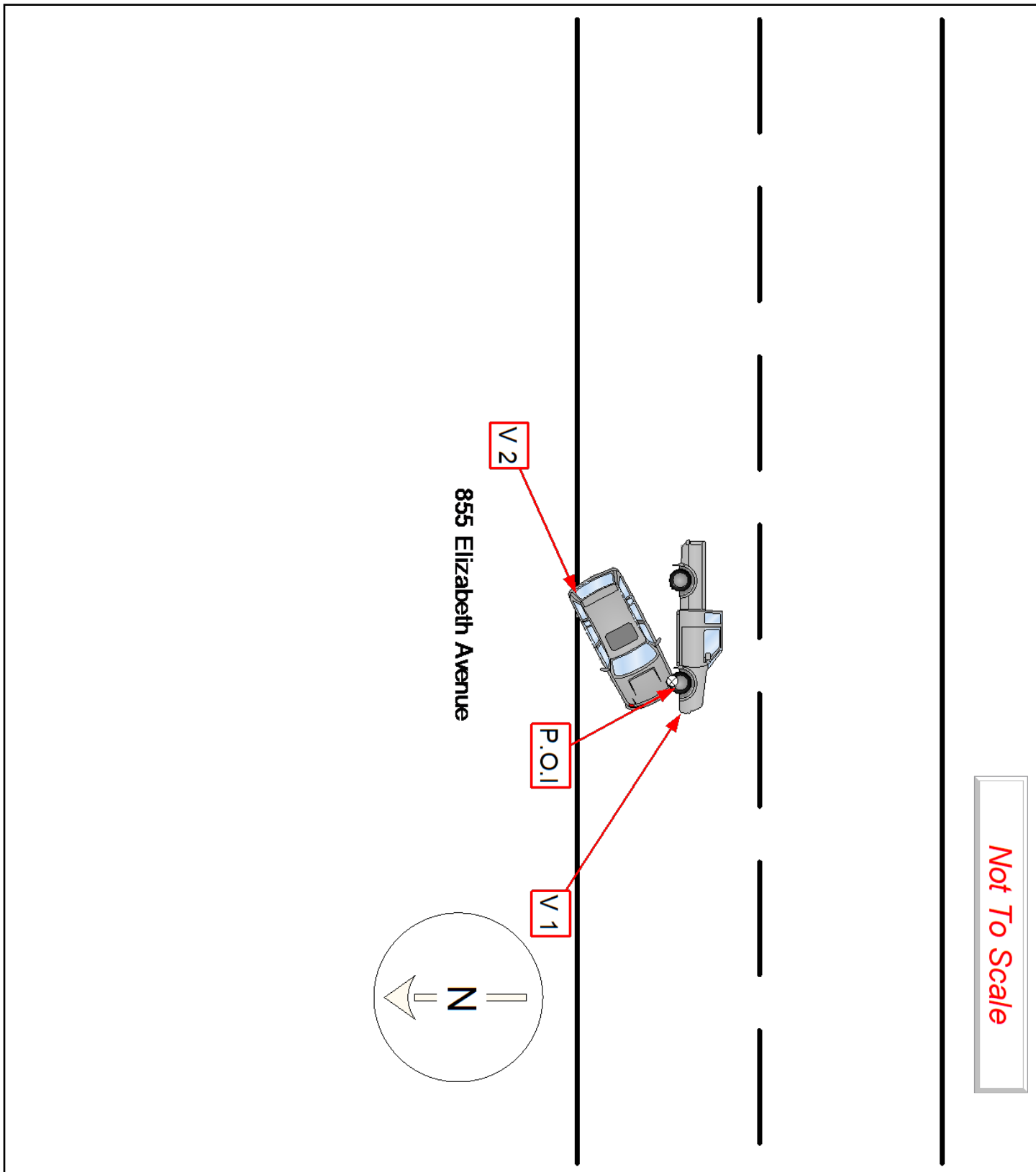
145. Crash Description/Narrative
